Affidavit of Compliance

- I certify that I have reviewed the Bloomington City Code which pertains to the sale of tetrahydrocannabinol (THC) products. I further certify that I have read and understood the provisions and regulations contained therein. I understand that pursuant to the Bloomington City Code:
- THC products cannot be sold at a movable place of business, including mobile sale from motorized vehicle, mobile sales kiosks or trailers. I understand that no license shall be issued within 500 feet of any school. Only fixed location businesses in an authorized zoning area shall be eligible.
- I do hereby certify that I have implemented a program for instructing all employees in the legal requirements pertaining to the sale of THC products, including but not limited to, reviewing the law on the sale of THC products, providing information on the health risks of using THC products and requiring employees to request identification from every customer who appears to be under 30 years of age. Further, I certify that I have provided training to all employees on the sale of THC products, and said training including information that the sale of THC products to a minor is illegal, what proof of age is legally acceptable and that a sale to a minor subject the employer and the employee to criminal and/or civil liability.
- No THC product sales are allowed by vending machine.
- No sales are allowed by self-service merchandising. All THC products must be stored behind the counter or other area not freely accessible to customers. This restriction does not apply if the licensee derives 90% of their revenue from THC product, or tobacco, and prohibits anyone under 21 years of age from entering the licensed premises.
- All THC product must be sold in original packaging with labeling compliant with the Minnesota Statute, section 151.72. An edible product must not contain more than five milligrams of any tetrahydrocannabinol in a single serving, or more than a total of 50 milligrams of any tetrahydrocannabinol per package.

I UNDERSTAND AND AGREE THAT: A criminal conviction will not bar an applicant from obtaining a license with the City of Bloomington unless such conviction is directly related to occupation for which the license is sought, according to Minnesota Statutes 364.03.

I HEREBY AUTHORIZE THAT: The City of Bloomington can investigate and make necessary to verify the information provided.
