2024 preliminary tax levy and budget

The Bloomington City Council will hold a public hearing on Monday, December 4 at 6:30 p.m. to hear from you regarding the City's proposed 2024 tax levy and budget. The hearing will be held in the City Council Chambers located at Bloomington Civic Plaza 1800 West Old Shakopee Road. The City's preliminary tax levy for 2024 was set by the Council on September 18, 2023 at \$81,618,819, a 9.49% increase from the 2023 tax levy. The levy amount can be reduced prior to final adoption but cannot be increased. KEY BUDGET FACTORS

- Non-Property Tax Revenue Projections**
 - Lodging and admission taxes projected to return to pre-pandemic levels by next year.
 - Permit revenues projected to be lower than recent years.
- Expense Drivers**
 - Continued investment in Public Safety by adding 6 full-time firefighters and an additional dispatcher.
 - Labor market pressure to attract and retain skilled workers.
 - Economic volatility effects on the cost of materials and services.



INCREASED PUBLIC ENGAGEMENT

- City staff has been out in the community gathering feedback on what residents value and prioritize when it comes to City budgeting.
- There have been budget tables at events across the city, held at different times and days of the week to reach more people.
- Budget tables have been staffed by department directors, members of the City Council, and finance representatives.

- Both in person and online feedback consistently demonstrate funding for public safety and parks and recreation as top priorities.
