ETIQUETTE, RULES and POLICIES

1. Swimmers under 11 years of age must be accompanied by an adult.
2. Swimming only in authorized beach area.
3. Inflated articles and floatation equipment are not allowed EXCEPT for U.S. Coast Guard Type I-III approved flotation devices, with an adult 18 years of age or older within arms reach at all times.
4. Glass containers are not allowed.
5. Throwing rocks or sand is prohibited.
6. No running or pushing from docks.
7. Swimming under docks is prohibited.
8. Dogs and fishing are not permitted in beach area.
9. No smoking or alcohol use
10. Pre-payment is required for all groups at least ONE WEEK in advance of reservation.
11. Payments may be paid at the Parks and Recreation office with Cash, Visa, MasterCard, Discover, or check.
12. Reservations and payments will only be taken at the Parks and Recreation office.
13. Cancellations and weather related cancellations must be made prior to 11:00 AM on the day of your scheduled reservation in order to avoid being billed/charged. Please call Parks and Recreation at 952-563-8877 to make a cancellation of a group reservation.
14. Included in the Group Fee is one bus parking pass. Additional vehicles and busses will be charged parking fees.
