



# Fireworks License Application

New  Renewal

No license shall be issued for the sale of permitted consumer fireworks at a movable place of business, including, non-permanent stands. No license shall be issued hereunder to transient merchants or as a seasonal or temporary sales's license. (14.442.23)

Only fireworks that are permitted by Minnesota Statute 624.20 shall be offered for sale.

*If applicant is an individual, it shall be completed by such person; if a corporation, by an officer; if a partnership, by one of the general partners; if an unincorporated association, by the manager or managing officer.*

**ATTACH:**

- A copy of the lease agreement, if the building is owned by someone other than the licensee.
  
- A letter from the property owner giving the applicant (lessee) permission to sell consumer fireworks from the leased premises.
  
- A detailed site plan illustrating and describing the proposed sales and storage areas, both on-site and off-site, covered by the license, identify customer parking availability and provide specific location for any off-site storage.
  
- A current Certificate of Liability Insurance. The minimum limits of coverage for such insurance shall be:
  - (a) Each claim, at least \$200,000; and
  - (b) Each incident, at least \$500,000.
  
- If under construction or undergoing substantial alteration, the application shall be accompanied by a set or preliminary plans showing the design of the proposed premises to be licensed. If the plans or design are on file with the City Building and Inspection Division, no plans need be submitted.

The data on this form will be used to approve your license. Some requested data may be private. Private data is available to you and the City or State staff who need this information to perform their duties, but is not available to the public. You are not legally required to provide this data, but the City may not be able to approve your license if you do not provide it.

**THE BLOOMINGTON CITY CODE, Chapter 1414.442.19 – 14.442.32, is available online at [Bloomingtonmn.gov](http://Bloomingtonmn.gov). I will familiarize myself with the provisions contained within.**

**REQUIRED PER CODE:**

- Fireworks shall be sold only to persons who are at least 18 years of age. Photographic ID required by state law.
  
- The fireworks display shall be located in a constantly attended area.
  
- Provide 2 fire extinguishers within 75 feet. One must be a water extinguisher
  
- Annual consumer fireworks license shall be displayed public view.
  
- Fireworks with damage packaging shall not be sold and immediately removed from the display area.
  
- No fireworks can be sold outdoors.
  
- A sign saying "FIREWORKS – NO SMOKING" shall be posted within 10 feet of the fireworks display.
  
- Call 952-563-8933 to schedule a site inspection with a Fire Inspector prior to selling fireworks.
