

ORDINANCE NO. 2022- 32

AN ORDINANCE AMENDING CHAPTER 1 OF THE CITY CODE TO ADD CHAPTER 12, ARTICLE VI AND CHAPTER 23, ARTICLE I TO THE LIST OF CITY CODE PROVISIONS THAT ARE ADMINISTRATIVE OFFENSES

The City Council of the City of Bloomington, Minnesota does hereby ordain:

Section 1. That Chapter 1 of the City Code of Ordinances is amended by deleting those words within brackets and ~~[stricken through]~~ and adding those words that are underlined, to read as follows:
