UNIT 1 traveling southbound on Bloomington Ferry Rd approaching the intersection with W. Old Shakopee Rd. UNIT 1 stated the light turned yellow and they sped up to make it through the intersection. Driver of UNIT 1 stated they did not see UNIT 2 until the crash. UNIT 1 and UNIT 2 crashed head on. UNIT 1 then crashed into the stop light pole. UNIT 1 had damage to the front of the vehicle. The front bumper had been torn off of the vehicle. The front drivers side tire was broken off. The front airbags of UNIT 1 were deployed. Driver of UNIT 2 stated they were Northbound Bloomington Ferry Rd waiting in the left turn lane to turn Eastbound on W. Old Shakopee Rd. from Bloomington Ferry Rd. Driver of UNIT 2 stated they saw UNIT 1 coming and thought they were going to stop with the yellow light. UNIT 2 proceeded to turn left through the intersection. UNIT 2 stated once they were in the intersection UNIT 1 crashed into front of UNI 2. UNIT 2 had damage to the front of the vehicle. The bumper of UNIT 2 was torn off. The front airbags deployed in UNIT 2. No injuries to the occupants of UNIT 2. Driver of UNIT 1 was transported to the hospital for possible injuries.
