On 09/09/2023 at approximately 1023 hours I was dispatched to a vehicle crash. Upon my arrival I observed a damaged motorcycle, and vehicle at the entry way of 35W south from 106th St. I met with both parties at the scene.

Unit 1 driver was driving westbound on 106th St waiting to turn left onto 35W South. Unit 1 stated he did not see the Unit 2 when he drove towards the on ramp. Unit 1 driver stated he hit the front end of the moped, and unit 2 driver was thrown from the moped.

Unit 2 driver stated that he was driving eastbound on 106th when he passed the entryway to 35W South. Unit 2 driver stated all he felt was an impact, and he was on the ground. Unit 2 driver stated he does not remember much after the collision.

There was a witness on scene that only observed the ending of the accident, and could not give additional details.

Unit 1 driver was cited for failure to yield to vehicle.

Driver #2 was eastbound American Boulevard in the curb lane. Driver #2 was stopped in traffic at the red semaphore with the intersection at Penn Avenue South. Stopped several 4 or 5 car lengths west of Penn on American Boulevard.

Driver #1 was eastbound American Boulevard towards Penn Avenue South. Per witness Kendra Goelz - Driver #1 was all over the road. She advised at one point he was up on the curb (south Side) and almost ran into a retaining wall. She advised he came back onto American Boulevard, swerved into the outside lane, served back into the inside lane, and ran right into vehicle #2 without braking.

Both driver of #2 and witness Goelz advised driver #1 appeared heavily intoxicated. Driver #1 advised witness Goelz that he had been drinking beer.

Driver #1 appeared to have urinated on himself, was unable to stand without falling, appeared very intoxicated, had blood shot/watery eyes, and smelt like an alcoholic beverage.

No field sobriety tests were done on driver #1 as he could not stand and to prevent injury. PBT 107948 was given and resulted in a .253 with a manual very short breath.

Driver #1 - Redmond arrested for DWI.

Driver #1 was DAC-IP.

Both cars towed.
Plates destroyed for vehicle #1.
