OFFICERS RESPONDED TO A SINGLE VEHICLE CRASH AT WEST OLD SHAKOPEE RD & FRANCE AV S. UPON ARRIVAL OFFCIERS OBSERVED VEH 1 WITH HEAVY FRONT END DAMAGE TO THE FRONT LEFT QUARTER PANEL AS WELL AS A FLAT TIRE ON THE FRONT RIGHT TIRE. THERE WERE ALSO SEVERAL DAMAGED CEMENT BLOCKS IN THE MEDIAN JUST EAST OF WEST OLD SHAKOPEE RD & FRANCE AV S THAT WERE KNOCKED OVER AS WELL AS A KEEP RIGHT STREET SIGN KNOCKED OVER.

THE DRIVER OF THE VEHICLE COMPLAINED OF NECK AND BACK INJURIES. THE DRIVER COULD NOT EXPLAIN WHY THEY HAD CRASHED INTO THE MEDIAN CEMENT BLOCKS AND STREET SIGN AND CLAIMED THEY WERE DRIVING THE SPEED LIMIT PRIOR TO THE COLLISION. THE DRIVER ALSO CLAIMED THEY ATTEMPTED TO STOP THE VEHICLE AFTER COLLIDING WITH THE FIRST CEMENT BLOCK, HOWEVER THE VEHICLE KEPT GOING. OFFICERS COULD NOT SEE ANY SIGNS OF IMPAIRMENT ON THE DRIVER, WHO CLAIMED THEY WERE HEADING HOME FROM WORK.

THE DRIVER HAD A VALID DL AND INSURANCE. THE DRIVER WAS ULTIMATELY TRANSPORTED TO THE HOSPITAL FOR THEIR INJURY. THE VEHICLE WAS TOWED TO THE CHIEFS TOWING LOT FOR DISABLING DAMAGE AND THE STREETS DEPARTMENT WAS NOTIFIED OF THE DAMAGE TO THE CEMENT BLOCKS AND STREET SIGN.
