SCOPE OF WORK DESCRIPTION:

The scope of work for this Project shall include, but not be limited to:

- Install (2) 1.5" conduits orange/blue throughout project as shown in the engineered drawing.
 - Install 12 AWG trace wire outside of the new conduits.
- Install (7) 30"x48"x36" hand hole as shown in the engineered drawings.
 - Install (7) Triview Test Station 72", with isolation lever.
 - Install (7) 8' Ground Rods in new HH's.
- Install a 144F as shown in the engineered drawings.
 - Existing Hennepin County Hand hole located in the NE corner of Old Shakopee Rd /CSAH 1 to the new hand hole located on the south side of 110th St east side of the Golf Maintenance entrance drive.
- Install 48F as shown in the engineered drawings
 - 48F from new hand hole located on the south side of 110th St. just west of the DWAN Golf entrance drive into the building.
 - 48F from the new hand hole located on the south side of 110th St. east side of the Golf Maintenance entrance drive into the building.
- Leave 100' slack coils attached to the sidewall in each hand hole & inside building
- All Permits & the following materials will be provided by LOGIS: Conduit, couplers, trace wire, hand holes, tri view test stations, 144 & 48 strand fiber
