Spoke with registered owner of U1 who said he gave D1 the car six months ago, and that she was supposed to get insurance and transfer the title. No insurance on U1. D1 said she was south on I-35W in the left lane, and didn't notice U2 beside her to the right when she went to change lanes. Merged into U2, sideswiping and breaking off U1's passenger side mirror and damaging U2. D2 gave the same story, U1 simply merged into him. U1 did have a child in the back seat who was uninjured and not identified. D1 cited for driving after revocation and no insurance.
