Unit 1 left Jefferson School parking lot and was heading east on 102nd St W. Unit 1 had a green traffic light and proceeded through the intersection. Once across the intersection Unit 1 was struck by Unit 2 who was traveling south on France Ave S. Unit 1 had damage to the driver side mirror and door caused by Unit 2.

Witness 1 stated her and Unit 1 left the school parking lot and were heading east on 102nd St W and had the green light. They proceeded through the intersection. Witness 1 stated Unit 2 did not stop for the red light and entered the cross walk striking Unit 1.

Unit 2 stated she was crossing the intersection and knew the light was red. Unit 2 stated she was impatient and attempted to cross the intersection. Unit 2 struck Unit 1 on the driving side and tumbled down the driver side of the vehicle. Unit 2 did not fall to the ground and did not hit her head on the ground.

Unit 2 was transported via Ambulance to the hospital.

On 05/18/2025 at 1900 hour I was dispatched to take a phone report of a Hit and Run Accident that occurred on the off ramp to Lyndale Ave S from I-494. The driver of Unit 1 said she was making a right hand turn to go southbound Lyndale Ave S from I-494 using the off ramp. While she was stopped waiting for traffic she was rear-ended by Unit 2. She exited the vehicle to exchange information. When she started talking to the driver of Unit 2 they became hostile and started to swear at her. Driver of Unit 2 said they did not have insurance and left the scene of the accident without exchanging any information.

While I was taking this report the Driver of Unit 2 called to report the accident.

Note: Both parties say the accident occurred between 1700-1715 hours.

Driver of Unit 2 said she was following Unit 2 to go Southbound Lyndale Ave S. Unit 1 left off the breaks to proceed then suddenly slammed on their breaks causing Unit 2 to rear-end Unit 1.

Driver of Unit 2 said that she tried to exchange information with Driver of Unit 1 but she was hostile and disrespectful. She said her kids were crying and she did not want to tolerate the disrespect and left the scene of the accident. Driver of Unit 2 also said there was no insurance for the vehicle. It just came out of the shop and had the insurance taken off of it.

Driver of Unit 2 mailed a Citation for Uninsured Motor vehicle.
