UNIT 1 WAS TRAVELING WEST BOUND ON OLD SHAKOPEE RD.
UNIT 2 WAS TRAVELING WEST BOUND ON OLD SHAKOPEE RD.
UNIT 3 WAS TRAVELING EAST BOUND ON OLD SHAKOPEE RD.
UNIT 4 WAS TRAVELING SOUTH BOUND ON OLD CEDAR AVE.

UNIT 2 WAS COMING TO A STOP AT THE RED LIGHT. UNIT 1 HIT UNIT 2 FROM BEHIND AND CONTINUED TO PUSH THE VEHICLE FORWARD AS IF THE DRIVER KEPT THEIR FOOT ON THE GAS PEDAL.

UNIT 2 DRIVER GOT OUT TO CHECK ON UNIT 1 AND UNIT 1 CONTINUED DRIVING FORWARD PUSHING UNIT 2'S CAR WHICH CAUSE UNIT 2 TO RUN OFF THE ROAD TO PREVENT BEING RUN OVER.

UNIT 1 CONTINUED WESTBOUND THROUGH THE INTERSECTION STRIKING UNIT 3 HEAD ON. AND STRIKING UNIT 4 WHILE THEY WERE TURNING LEFT TO GO EAST BOUND ON OLD SHAKOPEE RD.

UNIT 4 HAD A GREEN LIGHT AND WAS YIELDING THE LEFT TURN WHEN UNIT 1 T-BONED 4'S VEHICLE.

UNIT 1 WAS SUSPECTED TO HAVE BEEN HAVING A MEDICAL EMERGENCY (SIEZURE). UNIT 1 WAS TRANSPORTED VIA AMBULANCE.

Unit 1 traveling southbound on France Ave S when it came to the intersection of 102nd St W. Unit 1 stated they had the green light. They stated Unit 2 was traveling northbound on France Ave S when they made a left hand turn to head west bound on 102nd St W. Unit 1 stated they did not have time to stop. Unit 1 had heavy front end damage from striking Unit 2 on the rear passenger side. Unit 1 was towed via Chiefs Towing.

Unit 2 stated they were traveling northbound on France Ave S and were turning west onto 102nd St W. Unit 2 stated they believe they had the green light. Unit 2 had rear passenger side damage and was towed via Chiefs Towing.

Witness 2 Statement:

Unit 1 had green through intersection, did not attempt to touch brakes. Unit 2 had green as well, attempted to turn Westbound on 102nd, misjudged turn. Unknown if because of the heavy rain or not.

Preliminary Statement

On 06/02/2025 at approximately 2020 hours, I Officer Okoi #399, encountered a traffic accident at 98th St and Dupont.

Observations/Statements

Upon arrival, I observed Unit 1 facing westbound in the intersection with moderate passenger-side damage, and the Unit 2 was parked in a nearby business parking lot. Both drivers declined medical attention. (A cadet and sergeant were initially assigned the call. Some investigating was already completed.)

Unit 1 Statement

Unit 1 stated she was driving southbound on Dupont, attempting to turn westbound on 98th St (Unit 1 must yield for traffic when making this turn) when Unit 2 was exiting Highway 35W south and driving through the intersection of 98th and Dupont with a green light. Unit 1 stated she turned and was struck by Unit 2 on her passenger front side, disabling the vehicle.

Unit 1 vehicle was towed due to disabling the front passenger wheel. Unit 1 parents arrived on the scene to take her home.

Unit 2 Statement

Unit 2 stated that he was exiting 35W S and driving through the green light at 98th St and Dupont when Unit 1 failed to yield, and he struck her passenger side. Unit 2 stated he attempted to stop, but it was too late.

Chiefs Towing towed Unit 2 vehicle because he did not have car insurance, and he left the scene with a friend.

Officer's Actions

I uploaded photos of the accident via Axon Capture. I exchanged information with both drivers. Unit 1 was cited for failure to yield, and Unit 2 was cited for No insurance. I completed a tow sheet for Unit 2 vehicle, requiring insurance to be provided for the vehicle release.
