The front of veh #2 struck the right rear passenger side of veh #1.

Driver #1 stated: She was e/b on W OSR. She was in the left turn lane to go n/b on Bloomington Ferry Road. She had a flashing yellow light. She did not see veh #2 as she made the left turn. She was then struck by veh #2.

Driver #2 stated: He was w/b on W OSR. He was either in the right or left straight lane, but thinks it was the right straight lane. He had a green light. Veh #1 was making a left hand turn from e/b W OSR to n/b Bloomington Ferry Road. He tried to stop, but could not in time and struck veh #1.

I attempted to contact a possible witness, Tom (651-249-8547), but he did not answer.

GN Resound at 8001 E Bloomington Fwy called regarding a vehicle near their building on the west side. The vehicle appeared to have been in an accident.

I responded to the scene. The vehicle (Vehicle #1) appeared to have been heading n/b and was going too fast to make the turn, which leads into the north entrance for GN Resound at 8001 E Bloomington Fwy. The vehicle then came to a stop in the grass next to a concrete slab.

I contacted the registered owner of the vehicle, who advised he was enroute to the location with a tow truck.

The owner advised: His son (Driver #1) was driving the vehicle early this morning. His son told him that the tires on the car popped and he lost control of the vehicle, which then left the roadway.

I talked to Driver #1 on the phone who stated: He was driving early this morning around 0100 hours. He thought he was going to be entering the freeway. He noticed that he was not heading towards the freeway and tried to slow down. He said his tires popped and he lost control. He then exited the road and slid on the grass before coming to a stop.

The owner had the vehicle towed. Unknown on the towing agency. I had to leave the scene.
