Arrived on-scene and spoke with rp/victim Anderson, Terry Charles - 6/11/1972, who advised the following:

He was driving MN plate SAB-848 westbound on 494.

He exited west bound 494 onto the off ramp with France Avenue South.

He was stopped at the semaphore with 494 waiting for cars going North on France Avenue before he could proceed.

He was rear-ended causing his head to hit the roof of his car.

He moved his car over the shoulder on France just north of the exit ramp.

He observed what appeared to be a red hatchback go north on France around his vehicle and proceed east on Minnesota Drive.

He did not get a plate or description of the driver.

Observed a good size lump on the left side of Anderson's head above his eye.

He denied wanting an ambulance, but stated he would go see a doctor later.

Observed damage to the rear bumper of SAB-848.

Observed an emblem from a "CHEVROLET" vehicle laying on-top of the damaged bumper indicating the suspect vehicle to be a Chevy.

The emblem was placed into evidence under tag #1.

The area was searched but no suspect vehicle was located.

Advised Anderson to have his wife monitor him for the night and advised to see his doctor.

Unit 1 was traveling eastbound on Old Shakopee Road West then entered into the turn lane to travel northbound on Normandale Blvd. Unit 1 drove through a red arrow, making a left turn to travel northbound on Normandale Blvd. As Unit 1 pulled into the intersection, Unit 1 hit Unit 2 which was traveling westbound on Old Shakopee Road. On 01/24/2026 at approximately 1124 hours officers were dispatched to a motor vehicle accident in the area of Old Shakopee Rd and France Ave.

Upon arrival officers located 2 vehicles near the south entrance to the Valley West Shopping Center.

I observed vehicle 2 in the west bound turn lane to enter Valley west and was facing Northeast. vehicle 2 had heavy front-end damage, moderate damage to the passenger side of the vehicle and the airbags were deployed.

I observed vehicle 1 partially on the west curb of entrance to the Valley West Shopping Center and was facing southwest. vehicle 1 had heavy damage to the front driver side of the vehicle.

I spoke with the driver and registered owner of vehicle 1, stated the following: she was exiting the parking lot next to Walgreens. She advised she saw no vehicles traveling west bound on Old Shakopee Rd. vehicle proceeded to cross Old Shakopee Rd to enter Valley West. Duncan advised this is when to crash occurred.

Assisting officers spoke with the driver and registered owner of vehicle 2, who stated the following. vehicle 2 was traveling west bound on Old Shakopee Rd. the driver of vehicle 2 believed vehicle 1 was turning into Valley west, when they collided

Assisting officers spoke to a witness, identified as who stated the following: she was facing east bound on Old Shakopee Rd and waiting to take a left turn into Valley West. she observed the vehicle 1 drive north bound across Old Shakopee Rd attempting to drive into Valley West. The vehicle 2 was traveling west bound on Old Shakopee Rd.
