On 12/28/2025 at approximately 1111 hours, I Officer Barnum was dispatched to the intersection of Normandale Boulevard and Norman Ridge drive for a three motor vehicle accident.

Upon arrival, the three vehicles involved were identified as follows:

Unit 1: blue, 2019, Nissan Rouge sport, (MN/04254580), Unit 2: white, 2015, Subaru Forester, (MN/087ZXT), and Unit 3: Silver, 2009, Dodge Grand Caravan, (MN/RRA929)

At this time, I obtained a statement from Unit 2. Unit 2 informed me that they were traveling north on Normandale Ave S. in the left lane when they approached Norman Ridge Drive. At this time, they stated that Unit 1 (MN/04254580) who was traveling south on Normandale swerved into their lane. This resulted in a head on Collision. Unit 2 stated they could see the vehicle swerving before the impact. Unit 2 stated that after the Collision, Unit 3 made contact with the passenger side of their vehicle. Unit 2 also stated that the driver of unit 1 did not come over and talk to either him or Unit 3 after the crash. Unit 2 stated that out of nowhere unit 1's driver left the scene in an unknown direction.

Around this time, I made contact with Unit 3's (MN/RRA929) driver. They informed me that they were traveling north on Normandale Blvd. in the right lane when they approached Norman Ridge Drive. Around this time, they observed unit 2 swerving going south on Normandale. They then stated that Unit 1 and 2 collided near Norman Ridge Drive which resulted in unit 2 making contact with their drivers side door and front bumper.

Both unit 2 and unit 3 stated they did not get a good description of the driver of unit 1.

Unit 1 and Unit 2 both required a tow. Unit 1 and 2 both had a combination of airbags deployed. Unit three did not require a tow and their airbags were not deployed.

No injuries reported at the time of the crash.

UNIT 1 found in the porkchop on the Northeast corner of the intersection of Old Shakopee Rd W. and Hampshire Ave S. UNIT 1 was on the North side of the traffic light and was facing westbound. There were tire marks in the westbound lane leading up to UNIT 1 which appear to indicate that UNIT 1 was traveling Westbound on Old Shakopee Rd W in the right lane prior to crashing. UNIT 1 appeared to have struck a road sign that was in the porkchop that UNIT 1 was located in. UNIT 1 was unoccupied. Side curtain airbags were deployed and there was damage to the rear drivers side tire. The rear drivers side tire was at roughly a 45 deg. angle instead of vertical. There was a large dent to the drivers side of UNIT 1 in front of the rear drivers side tire. There was no one around UNIT 1 and nothing in UNIT 1 with any names on it. No insurance information was found inside UNIT 1. UNIT 1 was impounded to Chief's towing.
