3 car accident. Veh #1 struck veh #2 and then struck veh #3. Veh #2 and Veh #3 were both towed by Chief's Towing.

Driver #1 and Driver #3 both claimed possible injury and wanted to see Paramedics. Driver #2 advised he was not injured. Driver #1 was transported to HCMC by Allina. Driver #3 was driven to hospital by her husband who arrived on scene. Driver #3 stated she was around 34 months pregnant.

Driver #3 stated: She was driving veh #3. She was on the ramp to France Ave S from E/B 494. She was in the right, left turn lane (middle lane). She had a green light and entered the intersection. There was also a truck making a left hand turn in the lane to her left. She was driving through when she was struck by another vehicle. The other vehicle also hit the truck.

Driver #1 stated: She was driving veh #1 southbound on France Ave S in the left lane. The light ahead (ramp from E/B 494 to France Ave S) turned red. She tried to hit the brakes, but slid on the icy roads. She crashed into the other two vehicles.

Driver #2 spoke to Officer Merseth #334 and stated: He was making a left hand turn to go n/b on France Ave S. He saw veh #1 southbound on France Ave S and tried to stop. Veh #1 had a red light. Veh #1 struck his vehicle and another vehicle.

Officer Merseth #334 cited Driver #1 for a semaphore violation (running a red light).

On 12/29/25 at approximately 1605 hours, I, Officer Miller was dispatched to the intersection of 24th Ave and Interstate 494 on the bridge for a report of a two-vehicle crash. I arrived on scene and located two vehicles in the left turn lane waiting to go Westbound 494 at the intersection. I saw a red Chevy Bolt Hatchback bearing MN LKX014 behind a Dick's Sanitation garbage truck bearing MN YCH9103 and bearing US DOT 1063316. As I stepped out of my squad car, I noticed that the entire street was covered in ice. The driver of Unit 1 stepped out and stated that he tried to stop, but due to the ice, he was unable to and slid right into the truck. Driver of Unit 1 declined medical attention and stated he was ok. Driver of Unit 2 approached and stated that he was ok and did not see any damage to the truck. Unit 1 had some front-end damage from the impact, but was still drivable. I took photos of both Units on scene. Driver of Unit 2 stated that he did not need to have anyone come out and inspect the truck before getting onto the Interstate. Both parties were provided the case number and informed to provide that number to their insurance for damages.

Driver of unit 1 The 2009 Ford Focus with MN license plate KCB048 gave the following statement.

According to Unit 1 driver he was driving northbound on Old Cedar Ave. S. through the solid green semaphore.

Unit 1 driver was driving through the intersection of Old Cedar Ave. S. and Old Shakopee Rd. E. when the driver of the Ford Escape (SWN693) turned left from the southbound lane of Old Cedar Ave. S. to go eastbound Old Shakopee Rd. E.

Unit 1 driver's Ford Focus front right passenger collided with the Ford Escape passenger side bumper and wheel well.

I spoke to the owner and driver of the Ford Escape who stated the following.

Unit 2 driver confirmed she was driving southbound on Old Cedar Ave. S. and attempted to turn left onto eastbound Old Shakopee Rd. E.

Unit 2 driver also confirmed the green semaphore was solid green when she initiated her turn.

It should be noted there is no green arrow at the intersection. Unit 2 driver needed to yield the right-of-way before initiating the turn eastbound Old Shakopee Rd.

Unit 2 driver also admitted she did not have any proof of insurance for her Ford Escape.
