ADVERTISEMENT FOR BIDS FOR LIFT STATION NO. 14 REHABILITATION

PROJECT INFORMATION:

The City of Bloomington will receive sealed lump sum bids until 11:00 A.M., Thursday, May 27, 2021 through the Bids and Tenders web portal. Bid documents will not be accepted in any other location or format. Bid documents sent directly to the City of Bloomington will be returned unopened and not considered for award. Bids will be opened publicly and read aloud during a live WebEx meeting immediately after the specified closing time. A link to the bid opening can be obtained by emailing purchasing@bloomingtonmn.gov. All bids submitted are to be valid for sixty (60) calendar days.

SCOPE OF WORK DESCRIPTION:

The scope of work for this Project shall include, but not be limited to the following for Rehabilitation at Lift Station 14:

- A. Installation of a new entrance to the wet well with new dormer, door, masonry and precast construction to create a new, separate entrance to the wet well.
- B. Replacement of dry well handrails, replacement of dry well fiberglass grating.
- C. Blast and clean the wet well, apply resurfacer material and apply fiber reinforced coating system. Abrasive blast the dry well and apply epoxy coating system.
- D. Remove existing HVAC equipment from dry well side and furnish and install new make-up air unit, ductwork distribution, gas detection and two new exhaust fans. Remove existing HVAC equipment from the wet well side and furnish and install new make-up air unit, ductwork distribution, gas detection and one new exhaust fan with VFD.
- E. Electrical and controls work to include:
 - 1. Powering HVAC, moving and replacing lights and switches
 - 2. Install explosion proof lights in wet well.
 - 3. Seal existing penetrations for float switches and remove existing float switches. New floats installed with cables routed to junction box.
- F. Start-up Services for all new equipment

COMPLETION TIME:

The expected Contract Award date is June 14, 2021. Work may not begin until a Notice To Proceed is given with the executed Contract. I agree to a Substantial/Final Completion of the Work in accordance the dates below. This is based on the Contractor being allowed to mobilize to the site and start work the week of June 21, 2021. Substantial Completion – June 3, 2022. Substantial completion is defined as operation of the station and all new equipment as intended. Miscellaneous site and/or interior work that does not impact operations may still need to be completed. Final Completion – July 15, 2022. Final Completion is defined as all work as noted in the contract documents being fully completed.

BID SECURITY:

A certified check or cashier's check payable to the City of Bloomington, or satisfactory Bid Bond executed by the Bidder and a licensed surety company must also accompany the Bid in an amount not less than five percent (5%) of the total Bid to be forfeited as liquidated damages in the event that the bid be accepted and the Bidder fail to enter into a written contract and furnish the required bond within ten (10) days after the award of the contract.

BIDDER QUALIFICATIONS:

All bidders and persons or companies providing a response/submission to the Advertisement for Bids of the City shall comply with the provisions of the statute. Per Minn. Stat. § 326B.701, unless exempt, any Person, as defined by Minn. Stat. § 181.723, subd. 1(a), who performs public or private construction services must register with the Department of Labor and Industry (DLI). Bidders must submit a copy of their Department of Labor and Industry (DLI) Building Construction Contractor Registration with the Bid.
