
KEEP OUR CITY LOOKING GOOD

Residents play an important part in maintaining our city's quality and appearance. The City has standards describing how property owners and residents must maintain buildings and grounds, and relies on residents to maintain their property. Residents should notify the City if a neighborhood property is becoming a problem. Here are some city codes regulating your house, neighborhood and pets. Report a nuisance or ordinance violation by calling Environmental Health at 952-563-8934.

STORAGE

1 Materials, machinery and equipment must be stored in a building or be fully screened from view.

2 Firewood stack sizes and location are regulated.





PETS

10 All dogs and cats must be licensed annually with the City and display their tags at all times. Rabies vaccination certificates for dogs and cats are required.

11 Dog enclosures must be screened from view of adjacent properties and be set back

10 feet from lot lines and 50 feet from adjacent homes.

Animal feces on public and private property must be removed by the pet owner.

13 Dogs must be kept under restraint by leash, a fence or voice command on owner's property.

14 Frequent, continued barking is prohibited. If you have a pet complaint, call Animal Control at 952-563-4942.

HOME OCCUPATIONS

15 Certain occupations are prohibited in residential zones, including manufacturing, retail and repair businesses.
Businesses that operate only by phone or mail are generally permitted.

REFUSE, LITTER AND WEEDS

- **3** Grass and weeds must be cut before they reach one foot high.
- 4 Compost piles must be screened and located in the rear yard at least 10 feet from property lines. Place grass clippings and leaves in the pile to be composted or have them removed by the garbage hauler.
- Waste, debris and refuse must be kept in an enclosed building or a closed container stored either in the garage or no more than five feet in front of the house/garage. Homes and businesses must have weekly refuse and recycling service.

PARKING OF VEHICLES

- 6 Vehicles must be parked in the garage or on an approved driveway. In certain circumstances, RVs may be stored in the back or side yard. For more on RVs, visit the City's Web site, keywords: Recreational vehicle.
- **7** Number of vehicles owned by the residents and parked outside the garage or on the street may not exceed four. This

does not include vehicles

belonging to visitors.

- **8** Unlicensed or inoperable vehicles must be stored in a garage.
- **9** Nonresidential vehicles and vehicles longer than 22 feet and/or higher than seven feet six inches may not park in residential areas. However, these vehicles

may be parked in the driveway, or in the street where allowed, when rendering a service. For more information on large vehicles, visit the City's Web site, keywords: Motor vehicle ordinance.
