## Bloomington Garbage and Recycling Program: Request for Door-Step Collection

---

The City of Bloomington understands the importance of a clean, litter-free and livable community and wishes to provide for cost-efficient collection of garbage and recyclables from residential properties. To achieve these goals, the City has implemented the requirement that residents must use the City-contracted garbage and recycling service.

Door-step Collection for garbage and recycling services provided by the City-contracted consortium (Bloomington Haulers, LLC) may only occur in accordance with the Bloomington Solid Waste Ordinance, Chapter 10. The ordinance states, Door-step Collection must first be authorized by the City as an accommodation to residents. This "Request for Door-step Collection" will be used by the City for review and verification to determine if the applicant has a valid need for this service.

Examples of a demonstrated need for Door-step Collection:

- The inability to bring trash, recycling and yard waste\* carts to the curb for pick up because of a disability, limitation or need of assistance.  
\*\* Yard Waste Door-Step Collection is available only to yard waste subscribers with a cart.
- Other justifiable needs for the resident at this address.

Examples of Door-step Collection:

- Containers are set out to a location accessible to both resident and hauler.
- Does not require hauler to enter resident's home or garage to access the containers.
- Does not require hauler to drive on private property.
