Council Actions - 12/19/11

- Order Killebrew Pedestrian Bridge Project
- Determine if properties south of Killebrew Drive should be assessed for the project

Pedestrian Bridge Project Overview

Pedestrian Bridge

- Enclosed bridge that spans Killebrew Dr
- South side Stair and elevator tower will provide access to the bridge from street level
- North side connects directly with new Radisson Blu (public easements through ramp to MOA)
- ADA accessible



Roadway Work

- Roadway work (completion of Killebrew turn lane project)
 - Postponed completion of Killebrew turn lane until after Radisson Blu and ped. bridge
 - Mill and Overlay from TH77 to 500' east of 24th Ave, including portions of frontage road south of Killebrew
 - Ordered, bid, funded separately from Pedestrian Bridge Project
 - Completed Fall 2012 or Spring/Summer 2013

Pedestrian Bridge Funding

- Estimated Total Cost = \$3,603,000
 - Federal Grant = \$1,008,000
 - City = \$1,372,000
 - Assessed = \$1,223,000
 - » max. assessment per 2008 Public Improvements agreement and petition

Calculating Assessments

- Total Estimated Assessment = \$1,223,000
- 4/5 Assessed to MOA
- 1/5 Assessed to south of Killebrew
- Approximate Assessment per sq. ft. (south of Killebrew) = \$0.20 / sf

Tentative Assessment Schedule

- Estimated completion date June 2013
- Special Assessment notices sent July 2013
- Public hearing August 2013
- Payment due (to avoid interest) November 29, 2013
- If spread over 20 years (with interest), first payment on property taxes – May 2014



Recommendation

 Staff recommends not assessing the properties south of Killebrew Dr.
