## Bloomington Garbage and Recycling Program: Request for Exemption

(A \$35 one-time non-refundable application fee is required. Fee covers administrative costs involved with processing application and verifying that property owners have an approved method of disposing of their garbage.

Checks can be made out to the City of Bloomington.)

---

The City of Bloomington understands the importance of a clean, litter-free and livable community and wishes to provide for cost-efficient collection of garbage and recyclables from residential properties. To achieve these goals, residents are required to use the City-contracted garbage and recycling service.

Exemptions from garbage service by the city-contracted consortium (Bloomington Haulers, LLC) may only occur in accordance with the Bloomington Solid Waste Ordinance, Chapter 10.06.02 (1). The ordinance requires City approval of the resident's application for an exemption. This "Request for Exemption" will be used by the City to determine if the applicant has an environmentally responsible method of disposing of their garbage meeting City, state and federal regulations.

City code allows for self-hauling of garbage to a State permitted solid waste facility or transfer station with proper documentation of proof as an acceptable form of garbage exemption. There may be other rare cases where the City will approve an exemption.

Sharing garbage service is not an approved alternative collection method.

**Please note:** Approval of an exemption includes exemption from collection of garbage, recycling, yard waste, bulk materials pickup services and from participating in the Citywide Curbside cleanup program.

Regular verification of proper disposal of garbage and waste will be made at the property for which the request for special service location is made. Residents may be required to verify eligibility annually upon City request. Evidence of improper garbage or waste storage, collection or disposal shall be reason to immediately require standard garbage set-out procedures and charges.*
