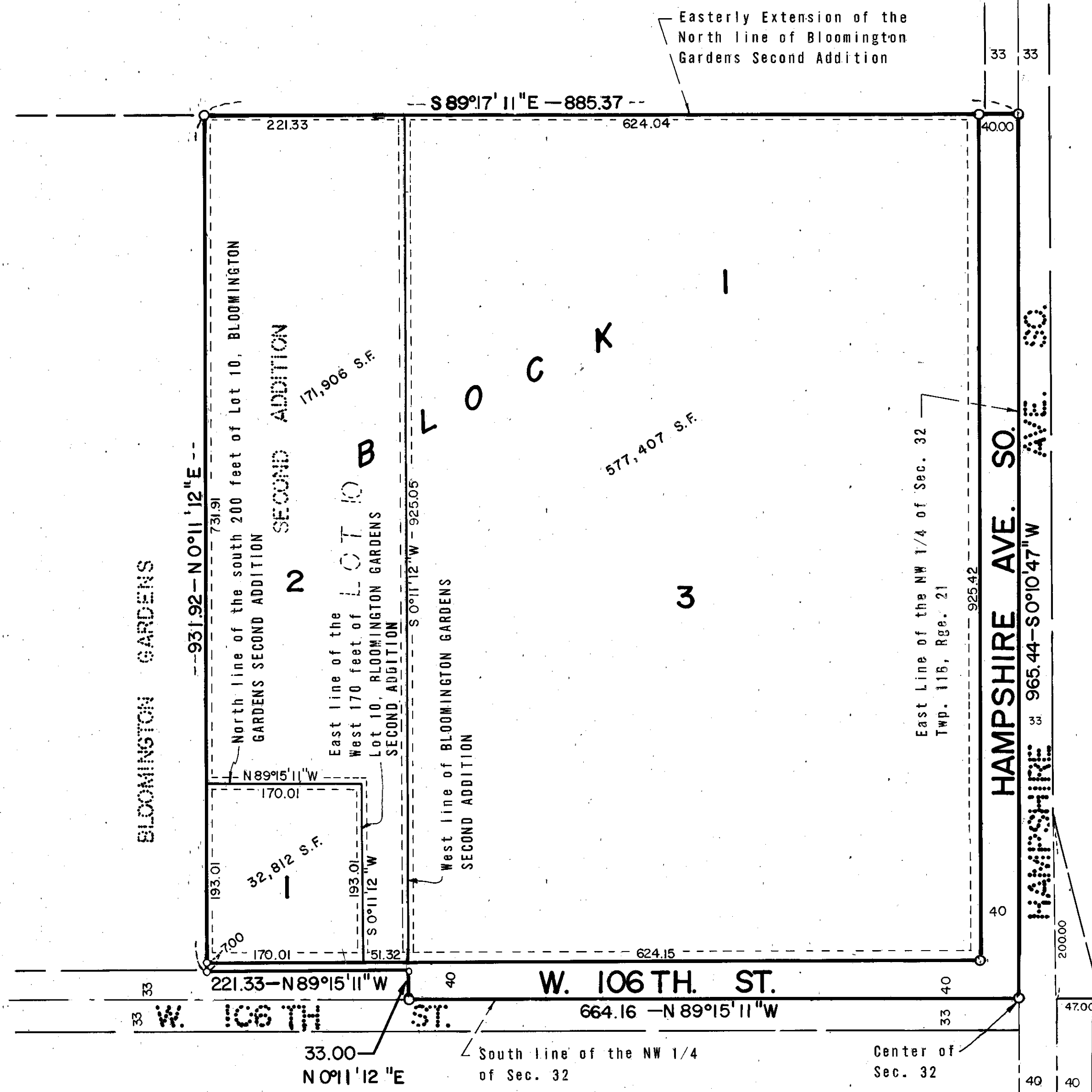
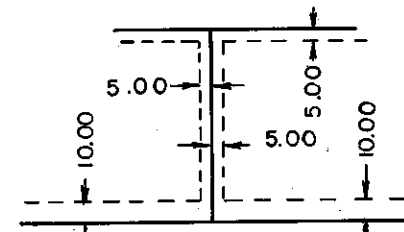


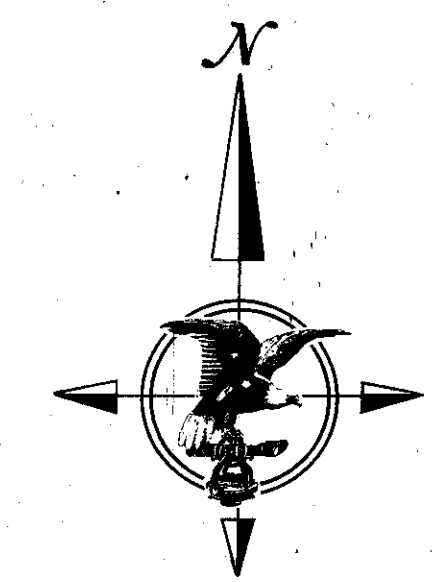
BLOOMINGTON 2ND ADDITION
