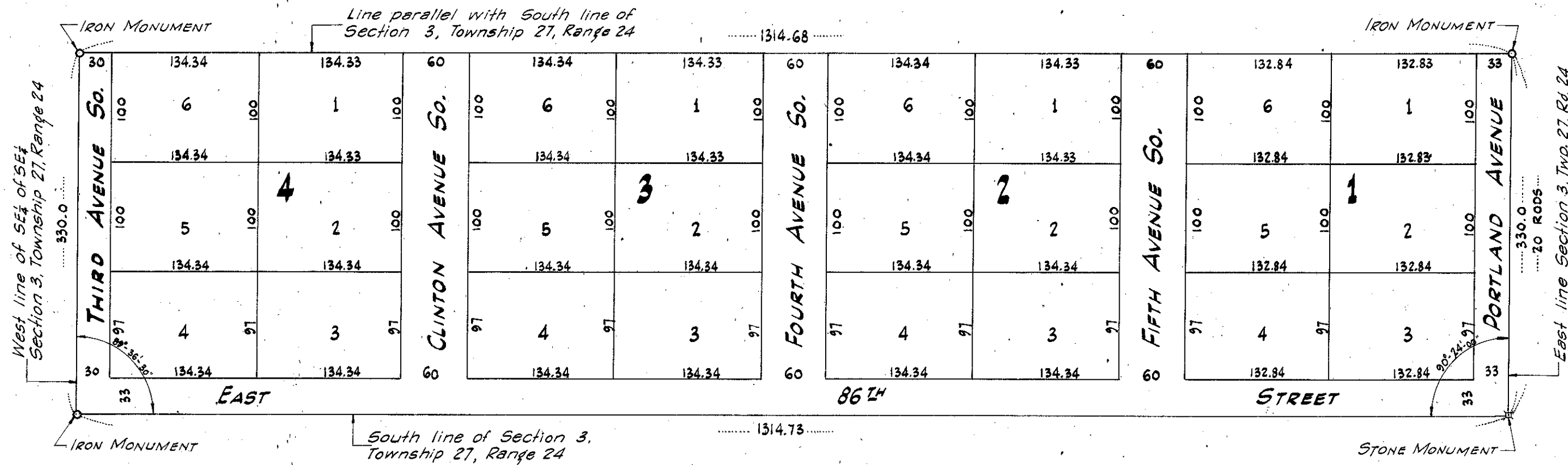


BROUILLARD'S ADDITION
