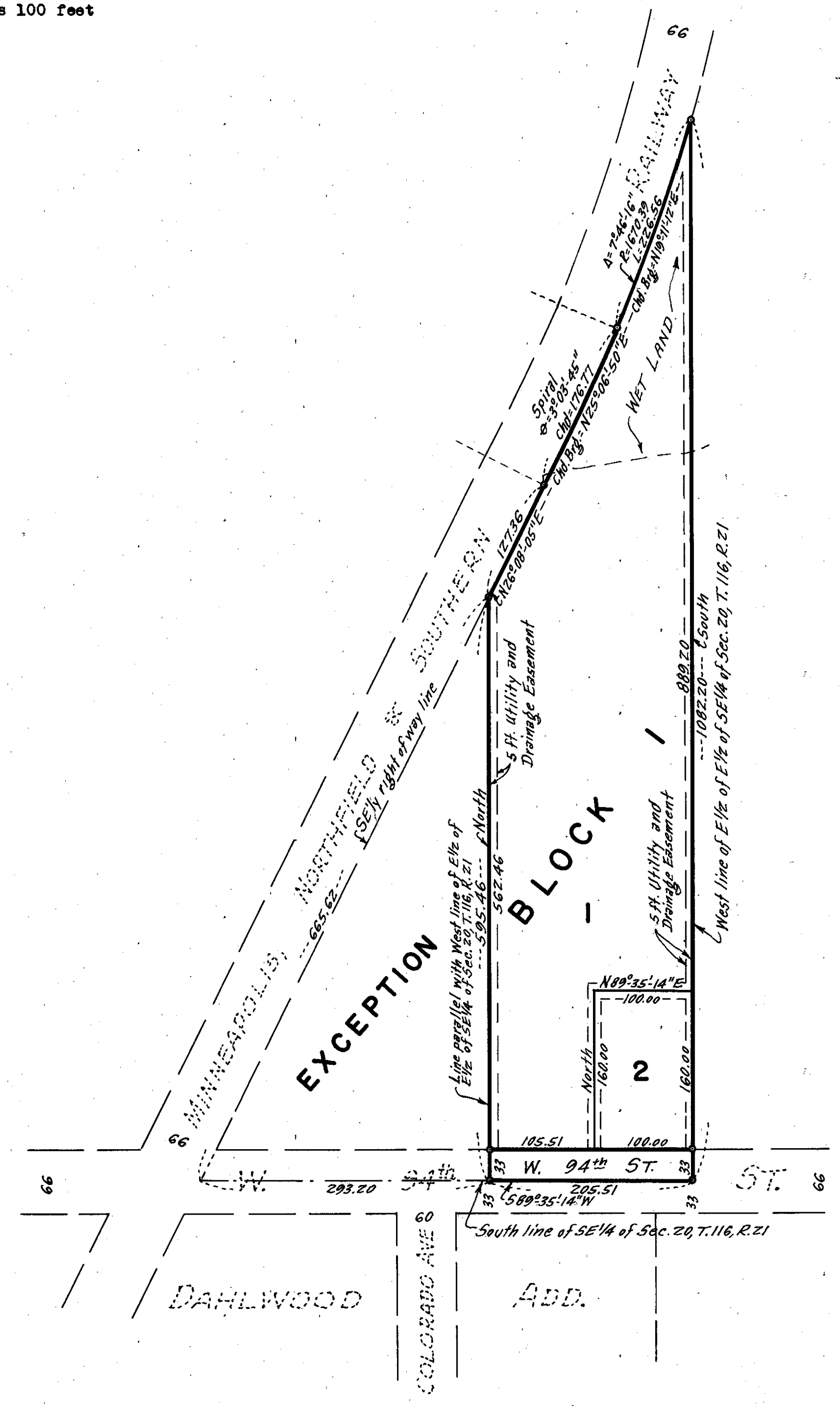


# CONAWAY ADDITION

Know all men by these presents that Orland L. Conaway and Mildred E. Conaway, his wife, owners and proprietors and First Federal Savings and Loan Association of Mankato, a United States Corporation, mortgage of the following described property situate in the State of Minnesota and County of Hennepin to wit: That part of the Southeast Quarter of Section 20, Township 116, Range 21, lying Southeasterly of the Southeasterly right of way line of the Minneapolis, Northfield and Southern Railway and West of the West line of the East half of said Southeast Quarter, except a tract of land described as beginning at a point of intersection of the Easterly line of the right of way line of said railway and the South line of said Southeast Quarter; thence East along said South line 293.2 feet; thence North, parallel with the West line of the East half of said Southeast Quarter, to the Southeasterly right of way line of said railway; thence Southwesterly along the Southeasterly right of way line of said railway a distance of 659.15 feet to the point of beginning.
