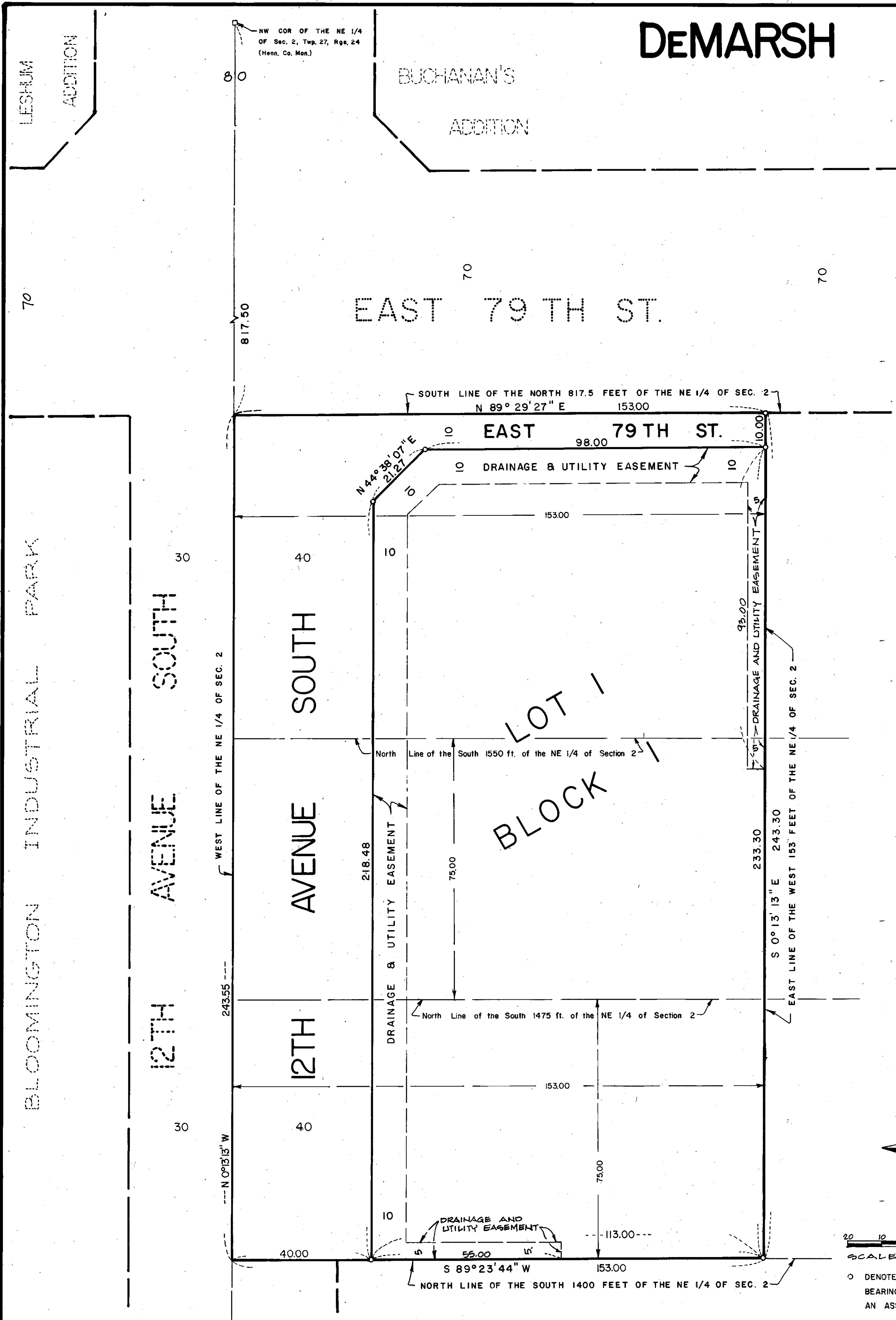


# DEMARSH ADDITION

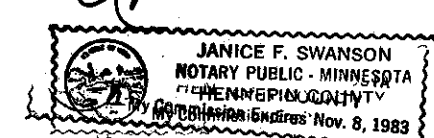

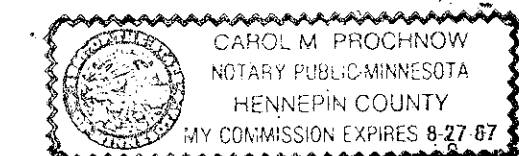

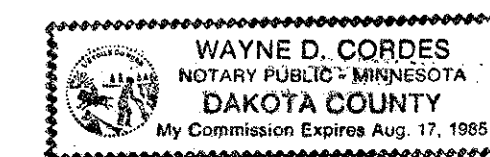
