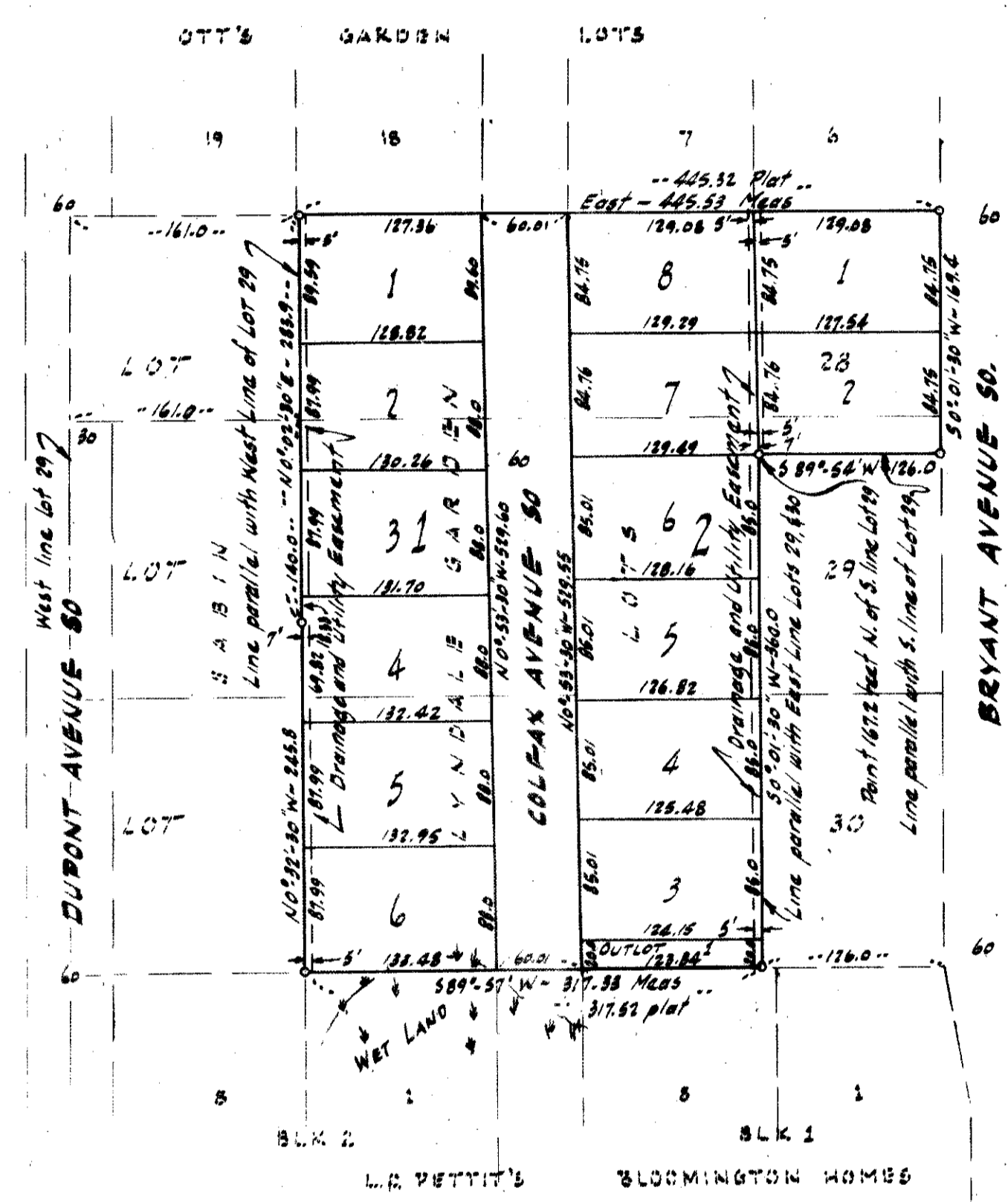


Dennis Butler Addition

Know All Men By These Presents: that the Anderson-Butler Construction Co., a Minnesota corporation, owners and proprietors and Rudolph S. Barck and Jessie Barck, his wife, mortgagees of the following described land situated in the County of Hennepin, State of Minnesota to wit:

The south 2 acres of Lot 28, Sabin Lyndale Garden Lots, except the West 161 feet thereof. Also that part of Lots 29 and 30, Sabin Lyndale Garden Lots, described as follows: Beginning at the Northeast corner of said Lot 29; thence West along the North line of said Lot 29 to a point therein distant 161 feet east of the Northwest corner of said Lot 29; thence south parallel with the West line of said Lot 29, a distance of 140 feet; thence southerly to the Northeast corner of Lot 8, Block 2, L. O. Pettit's Bloomington Homes; thence east along the South line of said Lot 30 to a point therein distant 126 feet west of the Southeast corner of said Lot 30; thence north parallel with the East line of said Lots 30 and 29 to a point 167.2 feet north of the South line of said Lot 29; thence east parallel with the South line of said Lot 29 to the East line of said Lot 29; thence north along the East line of said Lot 29 to the point of beginning, all in Section 9, Township 27, Range 24. Have caused same to be surveyed and platted as Dennis Butler Addition and do hereby donate and dedicate to the public for public use forever the street as shown on the annexed plat; and also subject to the utility and drainage easements as shown on the annexed plat.
