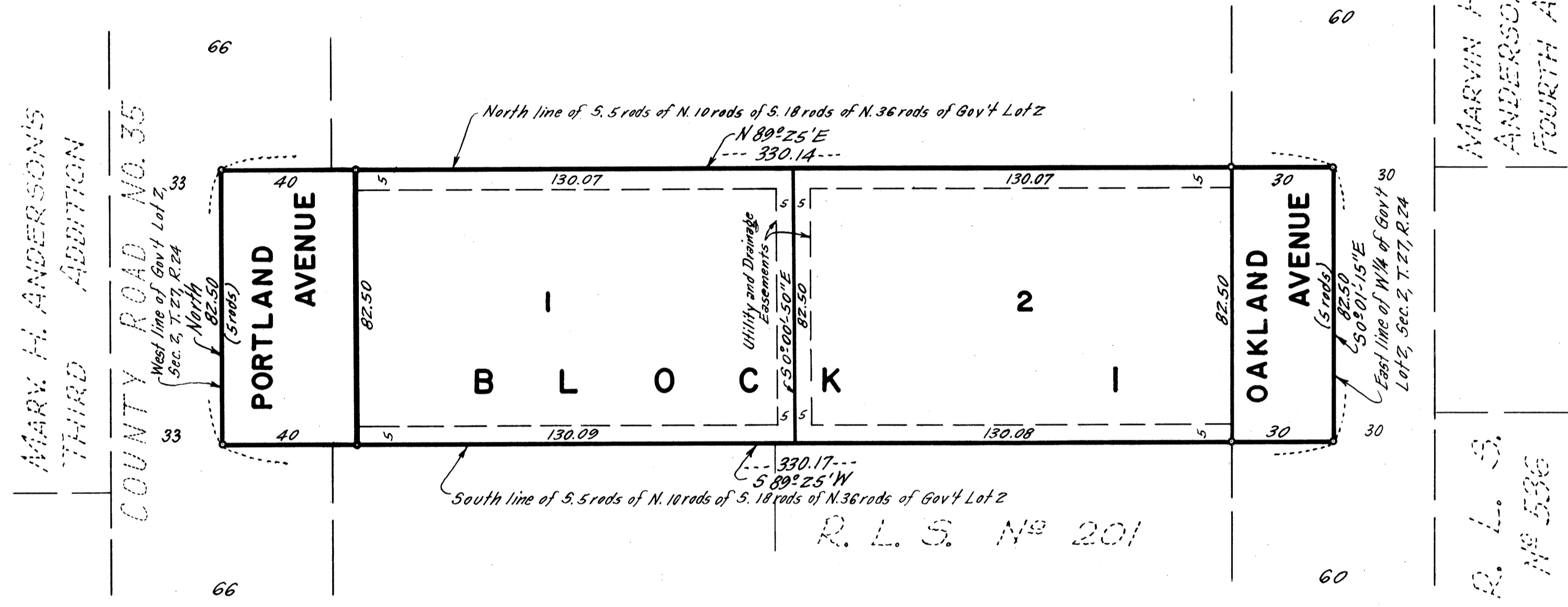


# EDEL ADDITION
