


GREEN GIANT ADDITION

KNOW ALL MEN BY THESE PRESENTS: That Green Giant Development Company, a Minnesota corporation, owner and proprietor of the following described property situate in the County of Hennepin, State of Minnesota to-wit: That part of the Northeast Quarter of the Northeast Quarter, Section 5, Township 27, Range 24, described as beginning at a point on the East line thereof distant 680 feet South along said East line from the Northeast corner of said Northeast Quarter of the Northeast Quarter; thence West, parallel to the North line thereof, to an intersection with the West line of the East One-fourth of said Northeast Quarter of the Northeast Quarter; thence South along said West line to the South line of said Northeast Quarter of the Northeast Quarter; thence East along said South line to the Southeast corner of said Northeast Quarter of the Northeast Quarter; thence North along the East line thereof to the point of beginning. According to the Government survey thereof.
