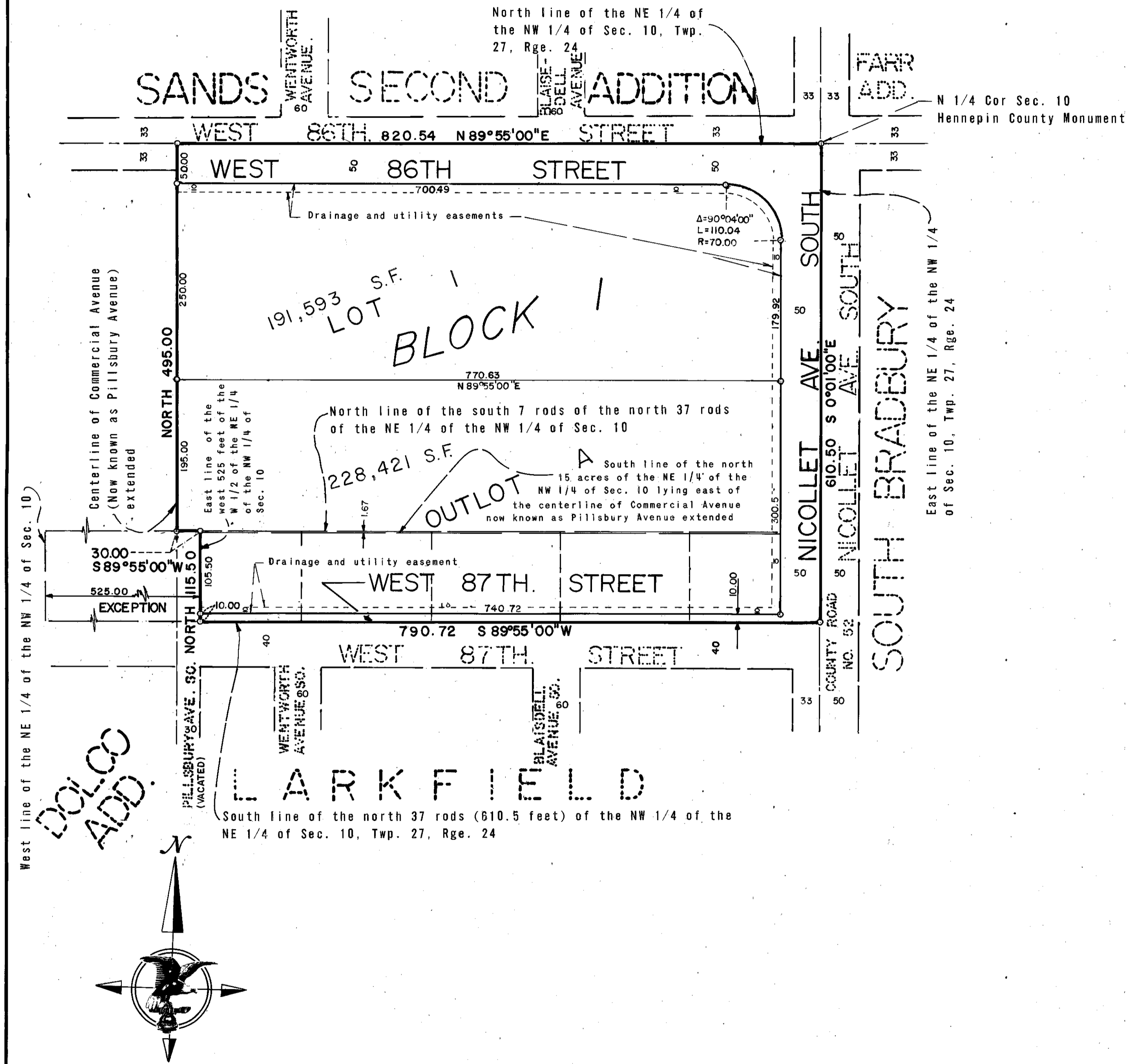


GROUP HEALTH PLAN 1ST ADDITION

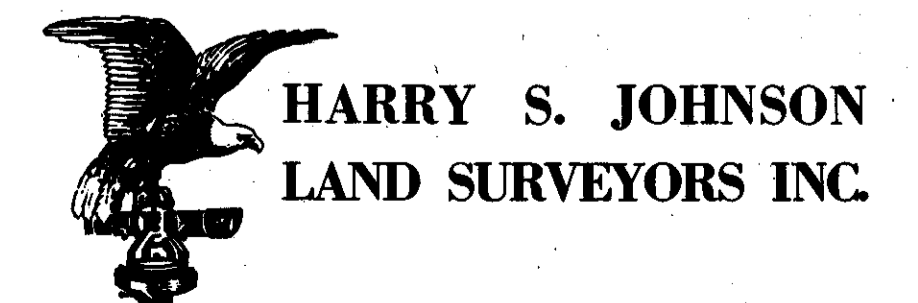
