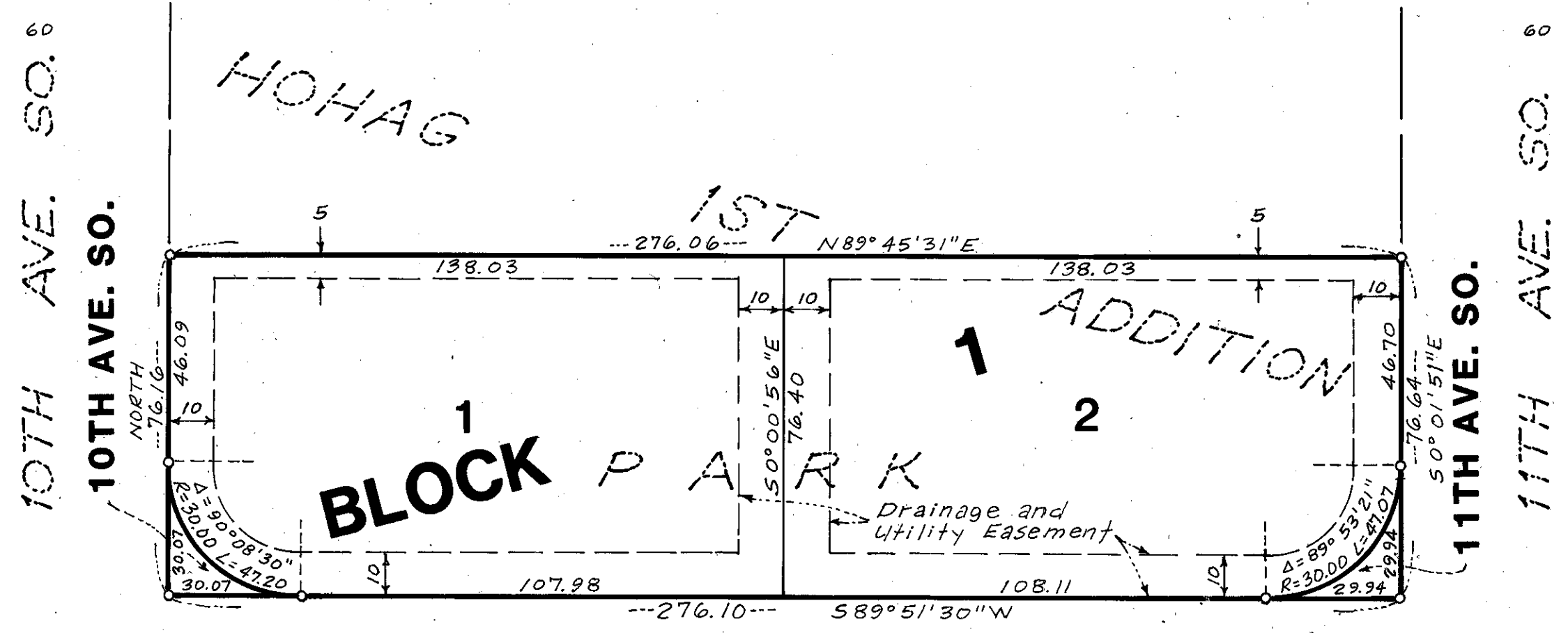
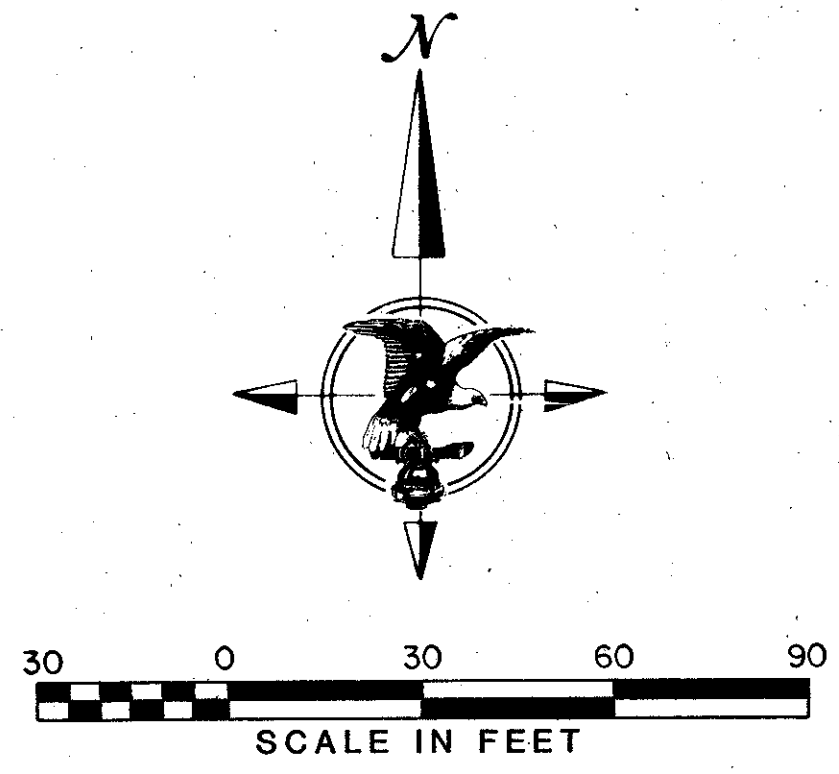

That part of Hohag 1st Addition designated as "Park", according to the plat thereof on file or of record in the office of the County Recorder in and for said County.

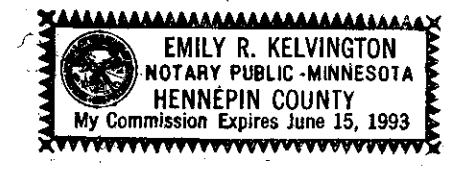

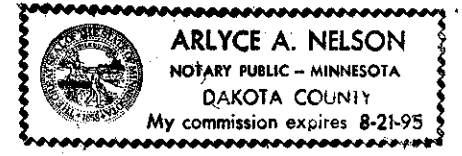
