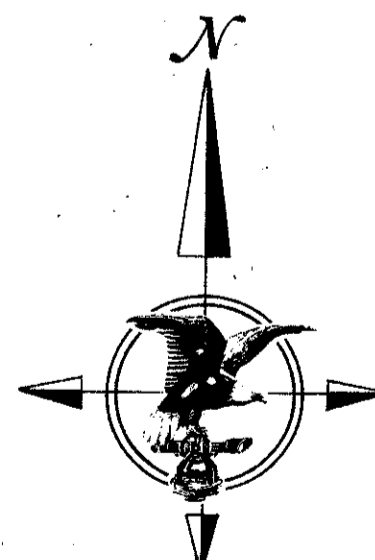
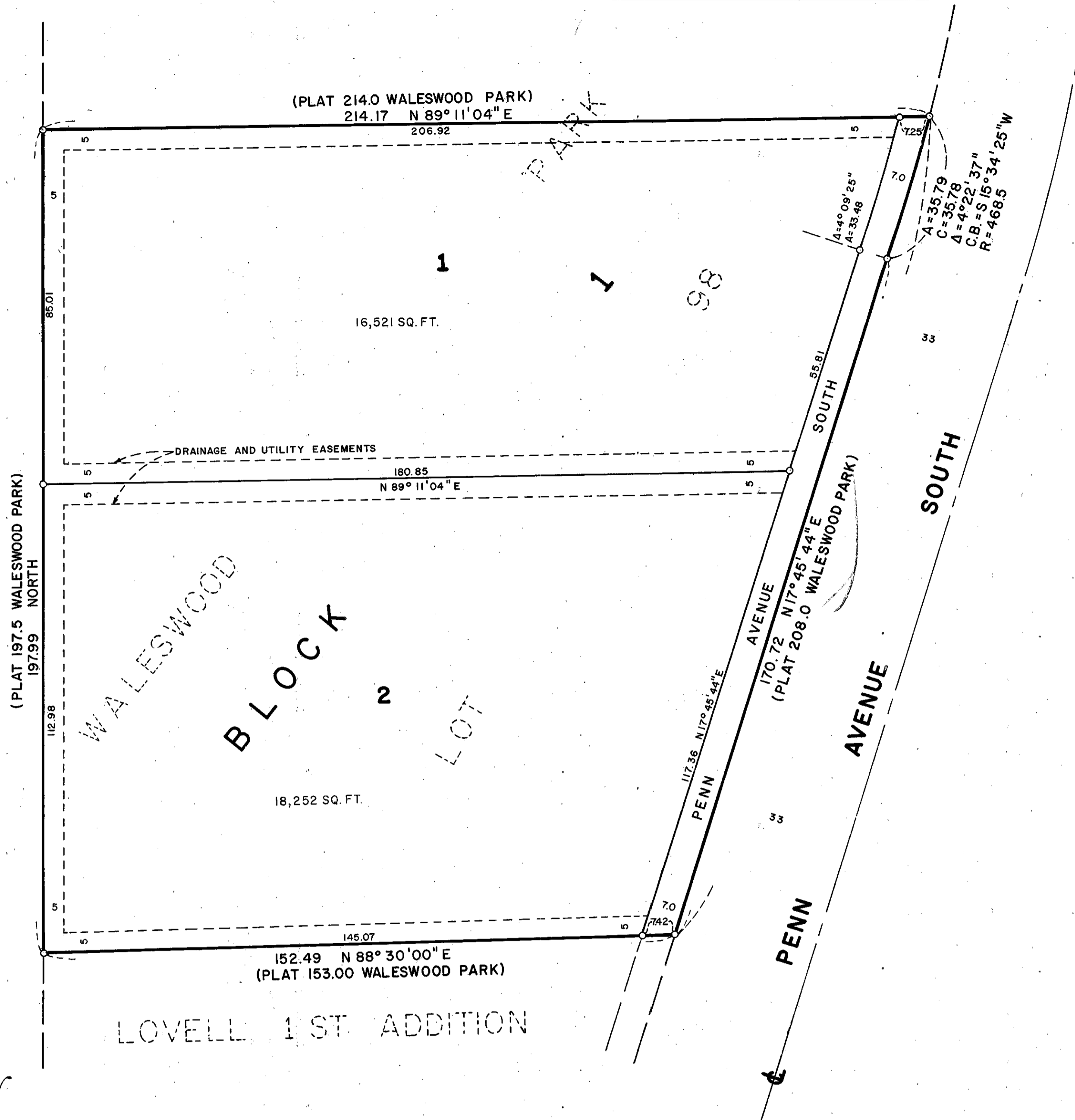


LOVELL 2ND ADDITION
