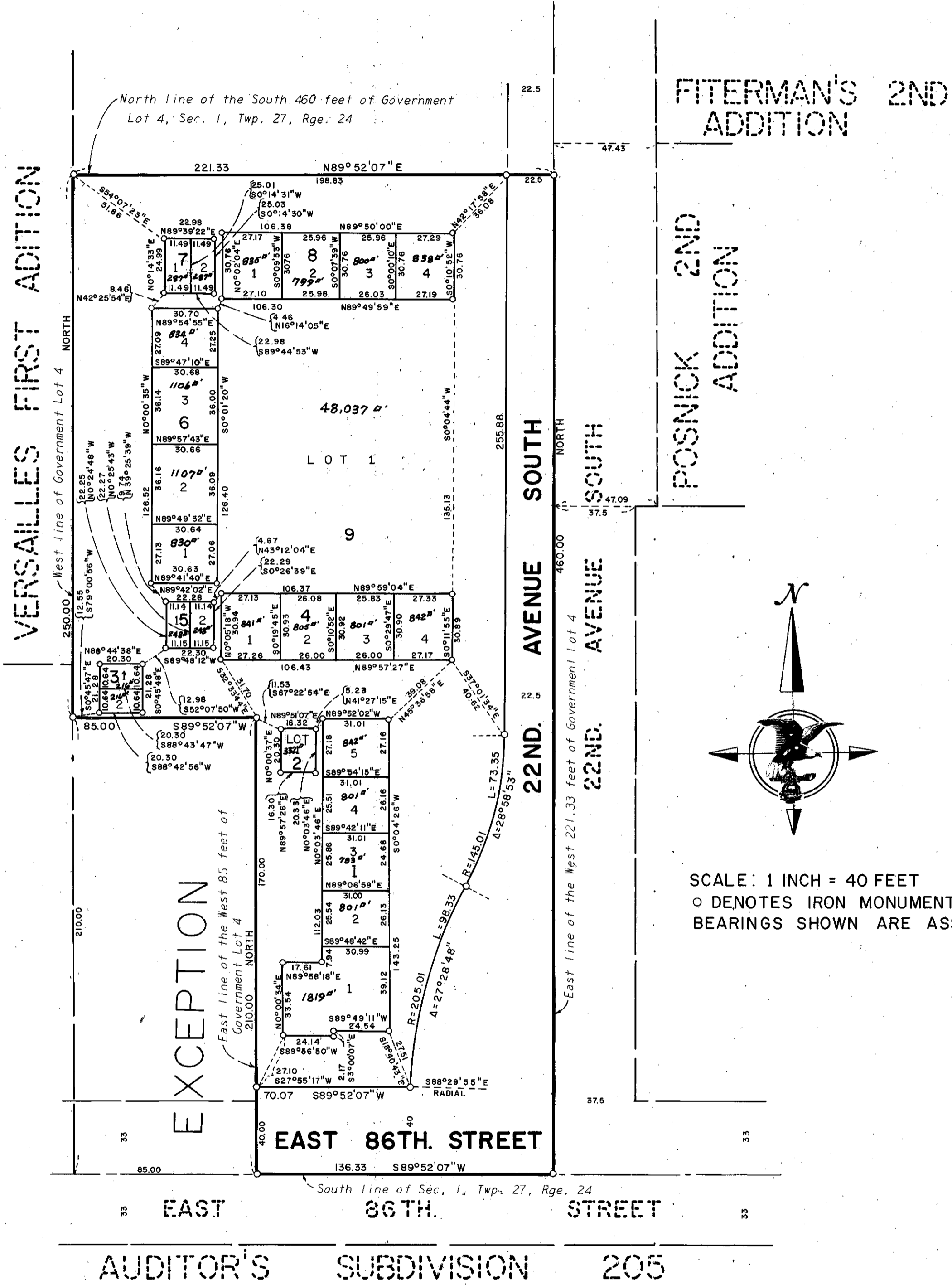


LYNN MARIE 1ST ADDITION
