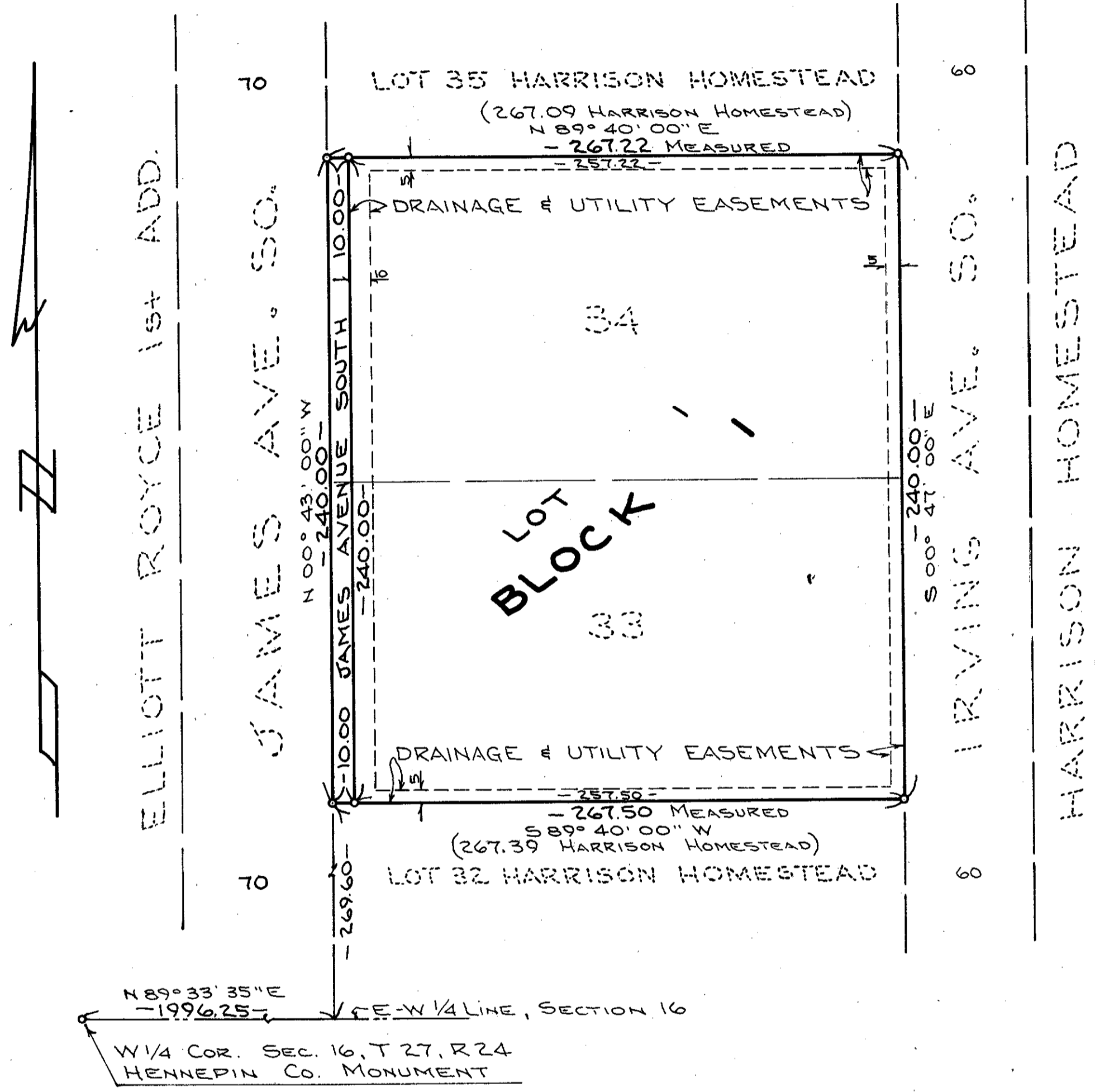


MOHAWK 1st ADDITION
