

KNOW ALL PERSONS BY THESE PRESENTS: That Darrell N. J. Norling and Sandra M. Norling, husband and wife, owners, of the following described property:

That part of the Southeast Quarter of the Southeast Quarter of the Northeast Quarter and Government Lot 7, Section 6, Township 115 North, Range 21 West, Hennepin County, Minnesota which falls within the following described area:

Commencing at the intersection of the north line of Government Lot 6, said Section 6, with the centerline of road, said point being 141.3 feet West from the northeast corner of said Government Lot 6; thence South 17 degrees 50 minutes East, 115.00 feet; thence South 27 degrees 50 minutes East along the centerline of road, 212.50 feet; thence South 44 degrees 10 minutes West along the centerline of road, 100.00 feet; thence North 89 degrees 12 minutes West along the centerline of road, 78.12 feet; thence South 06 degrees 13 minutes West, 33.14 feet to the southerly line of County Road; thence easterly along the southerly line of County Road 1,445.30 feet to point C which is the actual point of beginning; thence South 22 degrees 23 minutes West, 230.1 feet; thence South 42 degrees 54 minutes West, 233.60 feet; thence South 52 degrees 06 minutes West, 392.40 feet to point A;

And Beginning at point C, thence continuing easterly along the southerly line of County Road to a line 33 feet west of and parallel with the east line of Section 6; thence South parallel with the east line of said Section 6 and along the Westerly line of KENMARE SHORES according to the recorded plat thereof, said Hennepin County, 270.21 feet; thence southwesterly along said Westerly line KENMARE SHORES, on a tangential curve to the right with a radius of 310.99 feet, a distance of 313.81 feet; thence southwesterly tangent to the last described curve along said Westerly line KENMARE SHORES, 210.83 feet; thence South 71 degrees 44 minutes 29 seconds West along said Westerly line KENMARE SHORES, 26.31 feet to the most Westerly corner of Lot 1, Block 3, said KENMARE SHORES; thence North 51 degrees 05 minutes 31 seconds West 267.89 feet to a point distant 136.50 feet bearing North 52 degrees 04 minutes 29 seconds East from said Point A.




