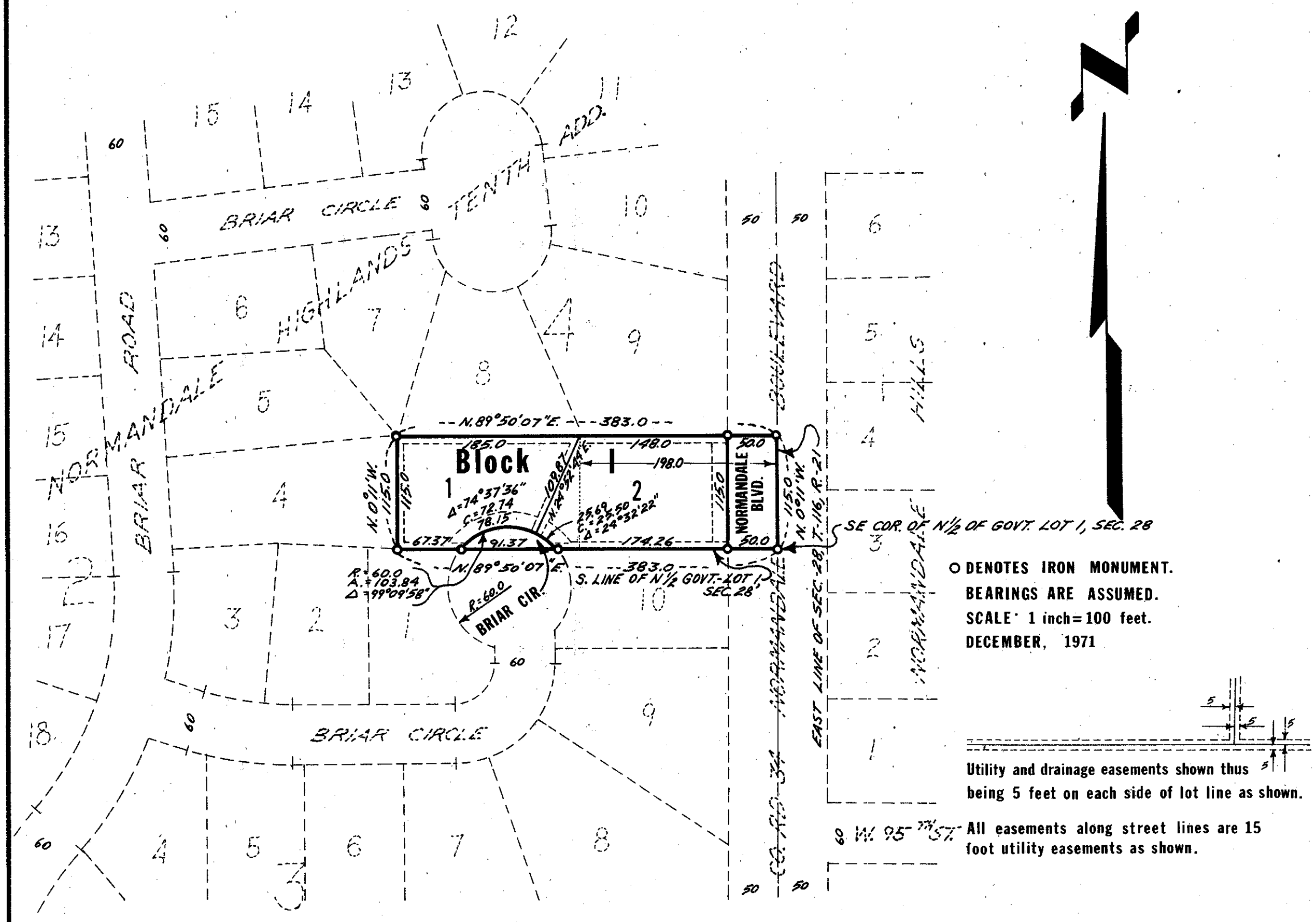


# NORMANDALE HIGHLANDS 11TH ADDITION
