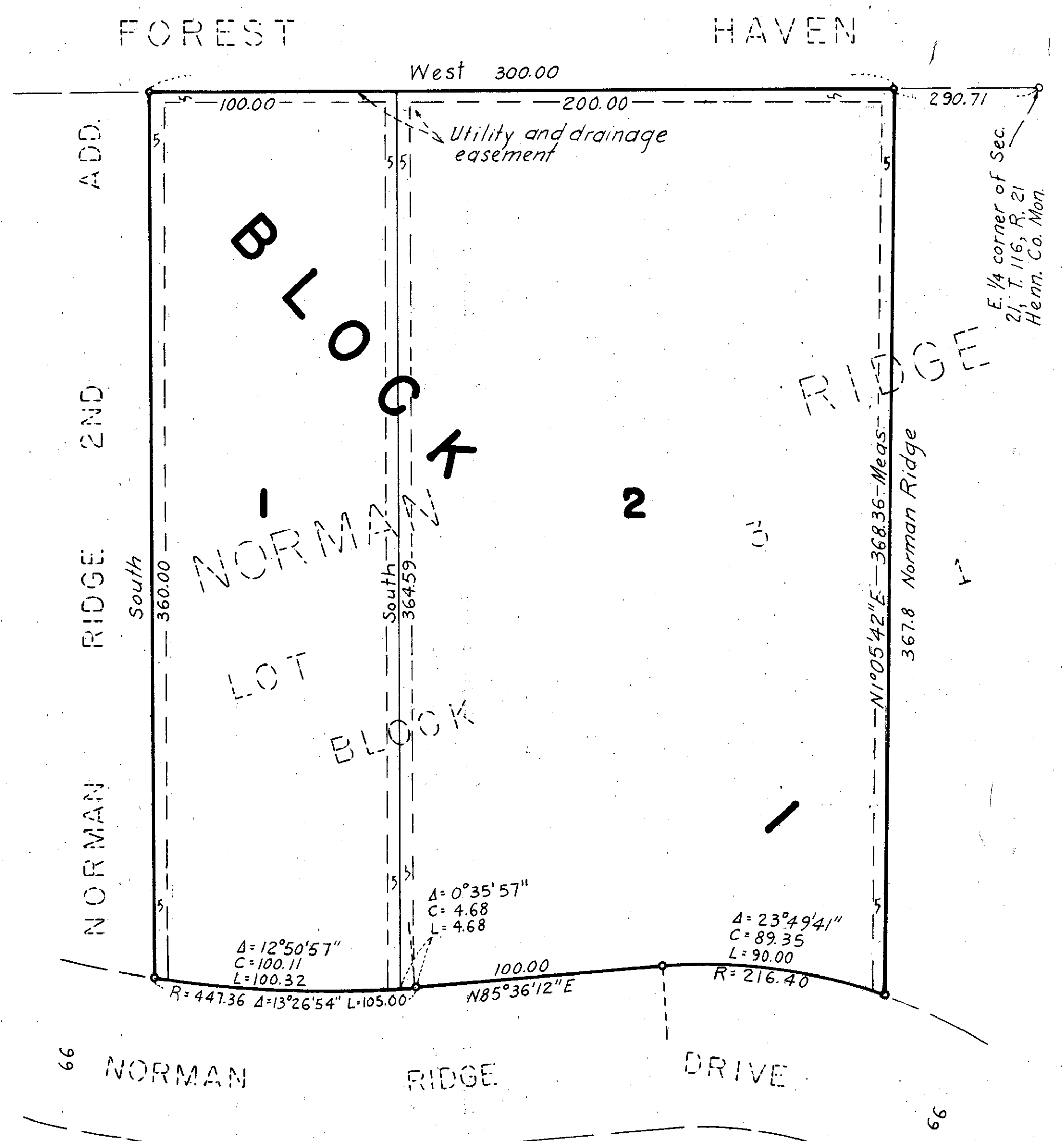


NORMAN RIDGE 3RD ADDITION

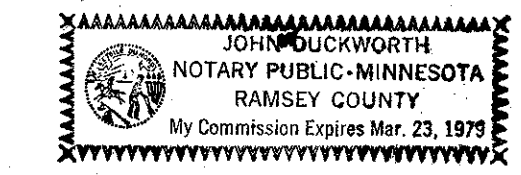

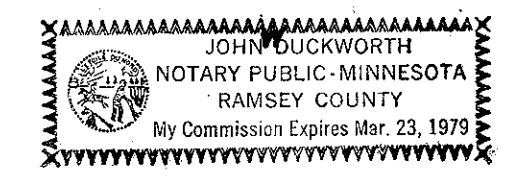
