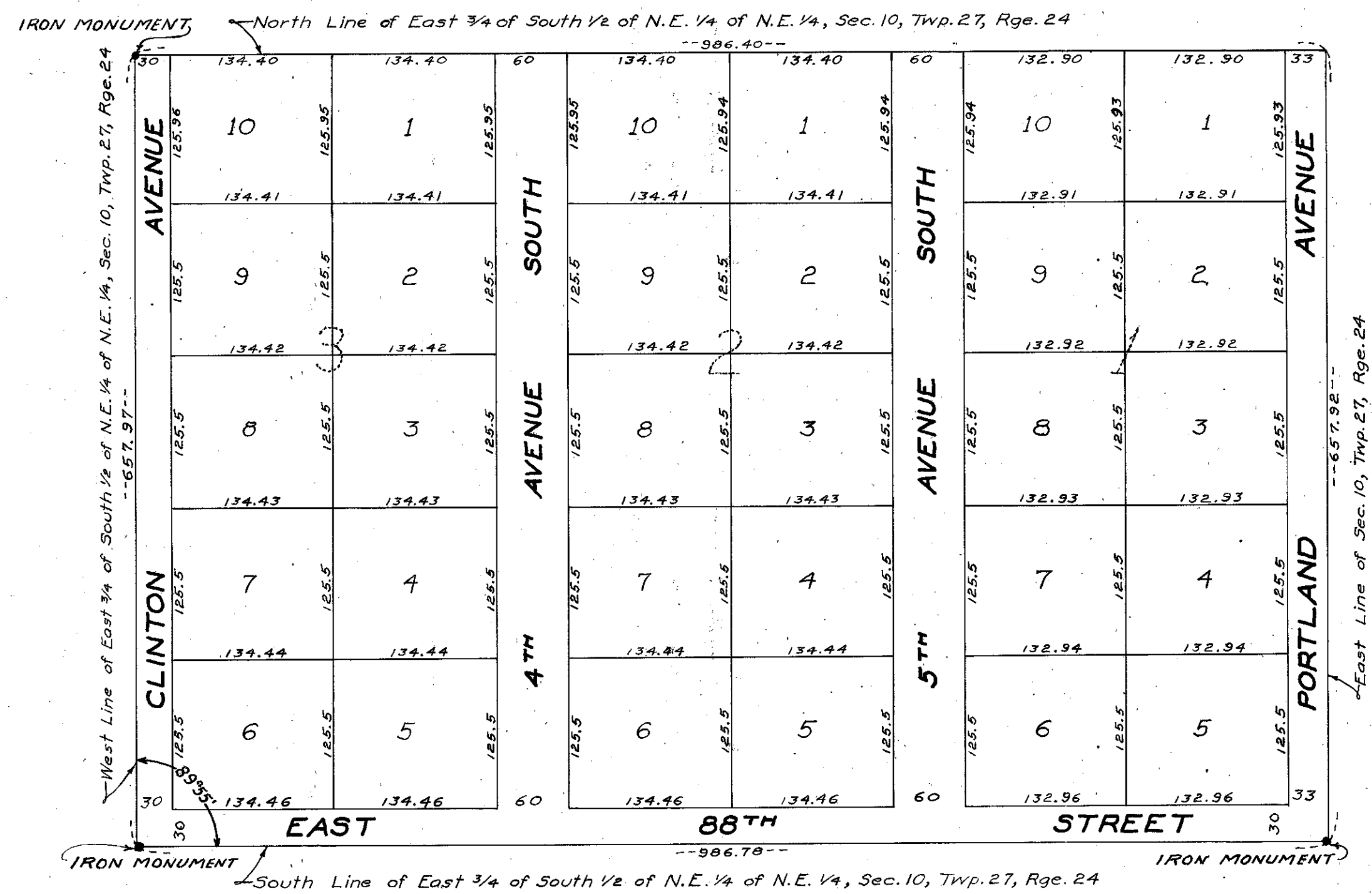


# PORTLAND PLACE
