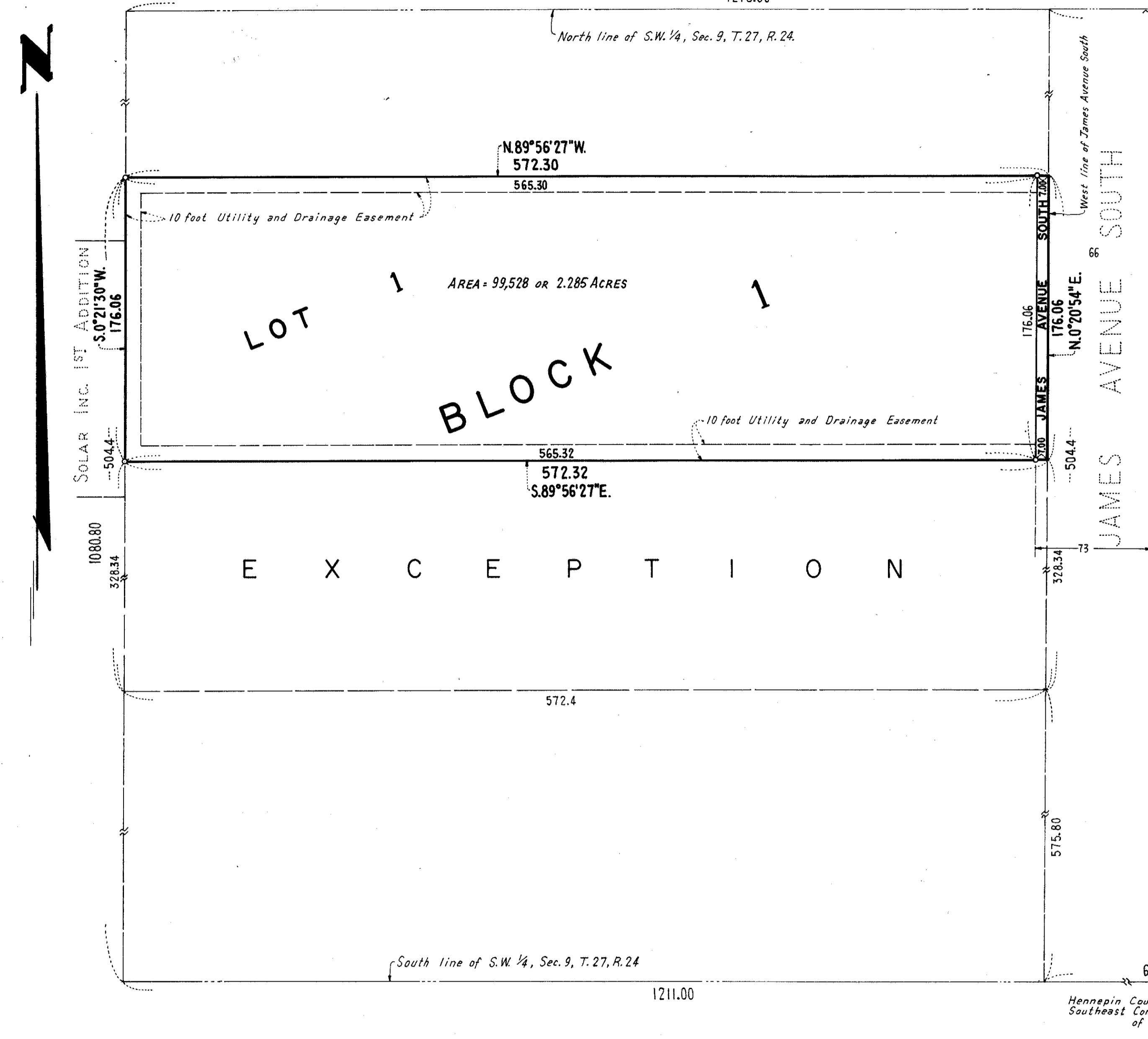


SENTY 2ND ADDITION

Know all men these presents that Carvel F. Senty, and Borghild Senty, his wife, owners and proprietors of the following described property situated in the State of Minnesota and County of Hennepin to wit: That part of the Southwest Quarter of Section 9, Township 27, Range 24 described as commencing at a point on the South line of said Southwest Quarter distant 638.5 feet West from the Southeast corner of said Southwest Quarter; thence North, along a line which intersects the North line of said Southwest Quarter at a point 638 feet West from the Northeast corner of said Southwest Quarter, a distance of 575.8 feet (said line being the West line of James Avenue South) to the actual point of beginning of the land to be described; thence continuing North along last described line a distance of 504.40 feet; thence West 572.30 feet to the point of intersection with a line drawn from a point on the South line of said Southwest Quarter distant 1211.0 feet West from the Southeast corner of said Southwest Quarter to a point on the North line of said Southwest Quarter distant 1210.0 feet West from the Northeast corner of said Southwest Quarter, said point of intersection being 1080.80 feet North along said line from the South line of said Southwest Quarter; thence South along said last described line 504.40 feet; thence East to the actual point of beginning, except the South 328.34 feet thereof, have caused the same to be surveyed and platted as SENTRY 2ND ADDITION and do hereby donate and dedicate to the public for public use the avenue and easements for utility and drainage purposes, as shown on this plat.
