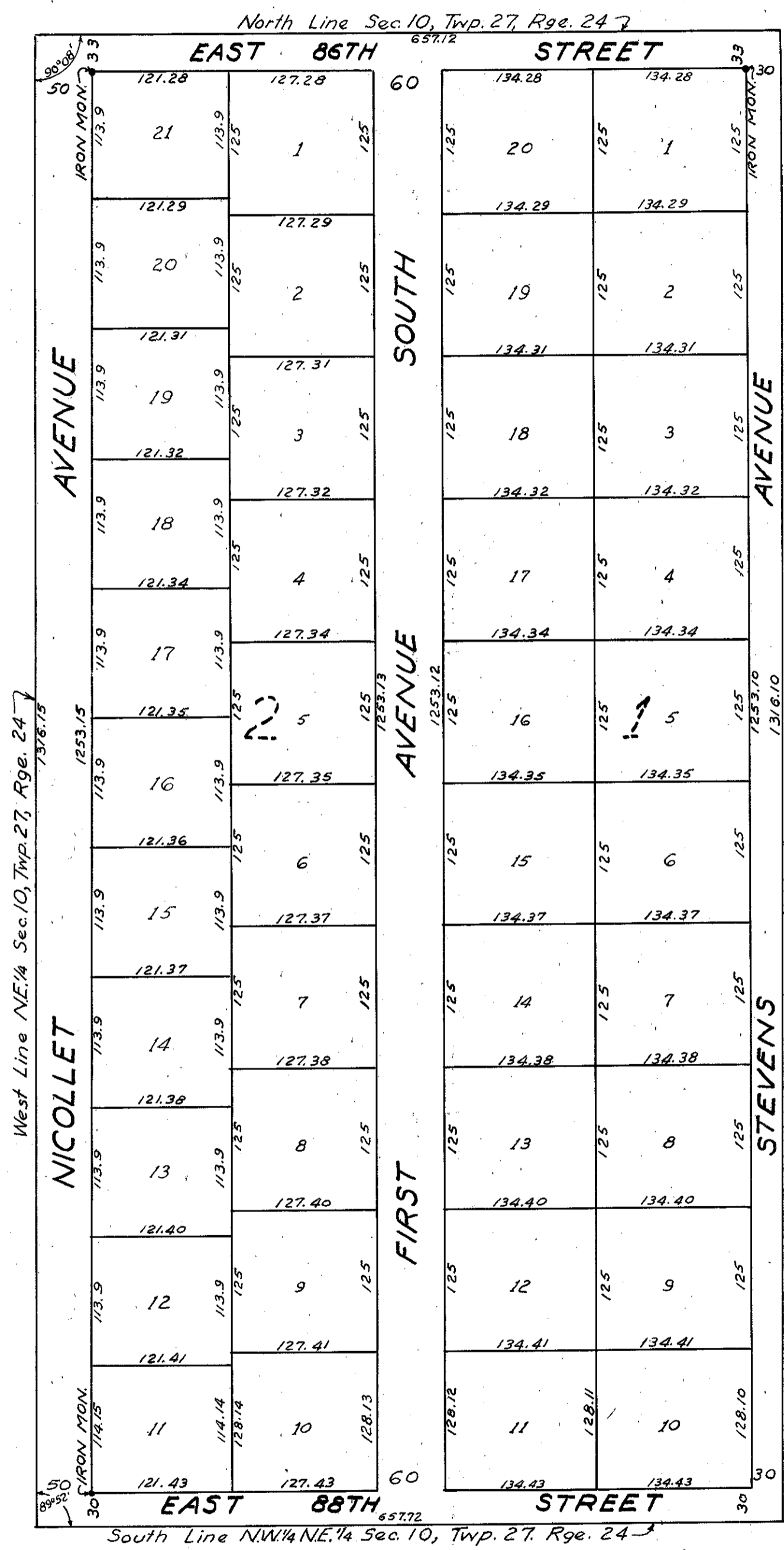


SOUTH BRADBURY
