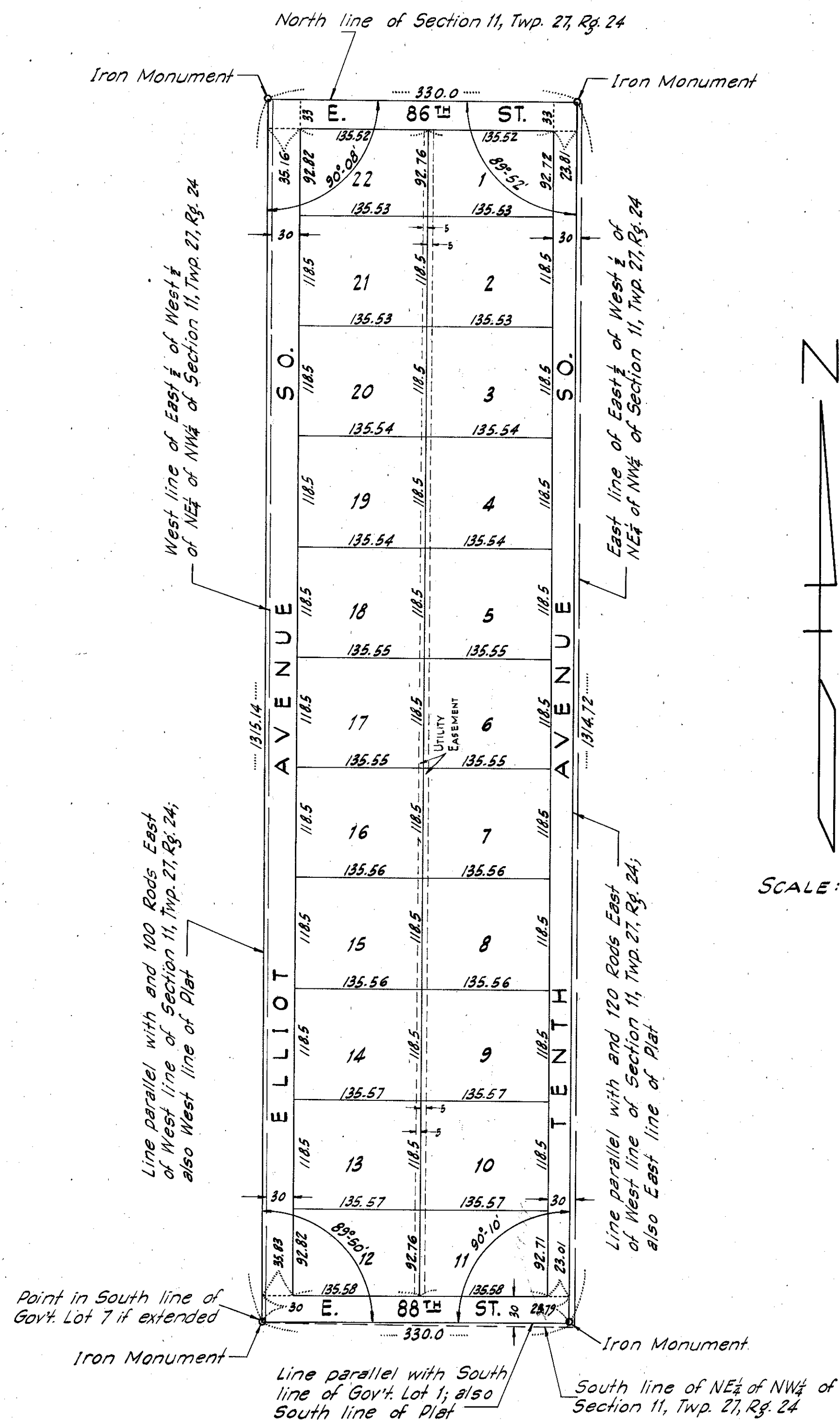


WALLOVER'S ADDITION
