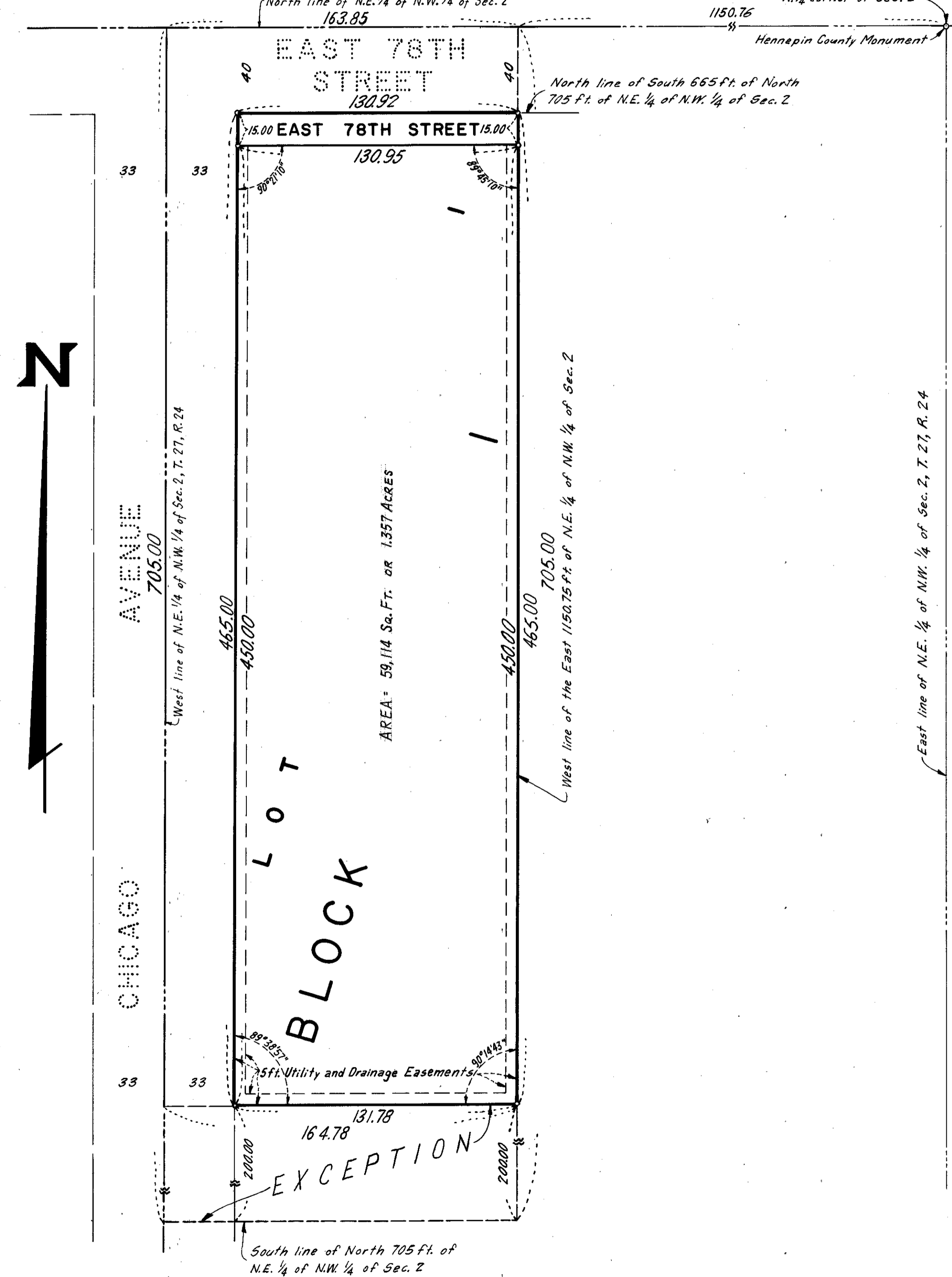


ANTHONY ADDITION
