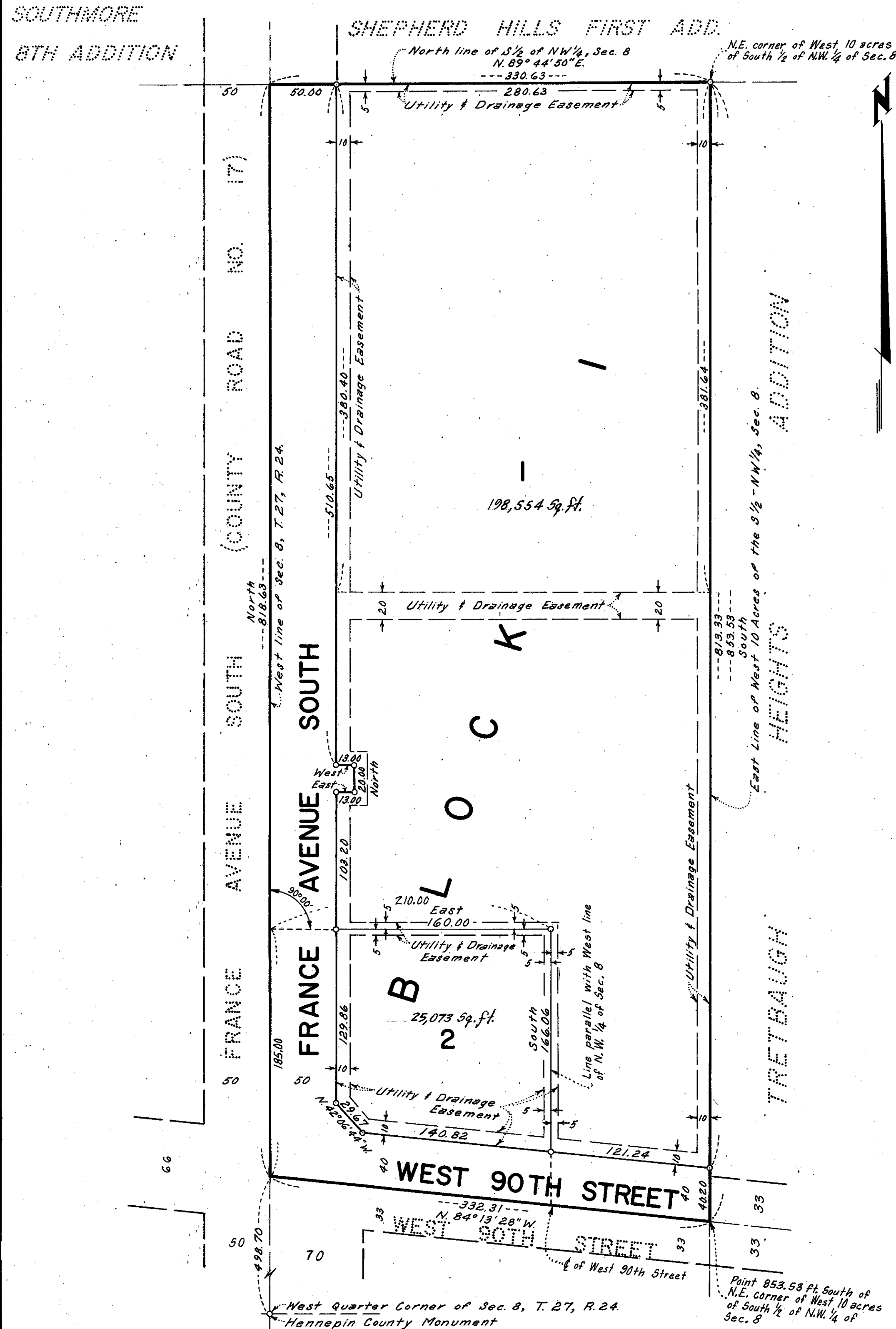
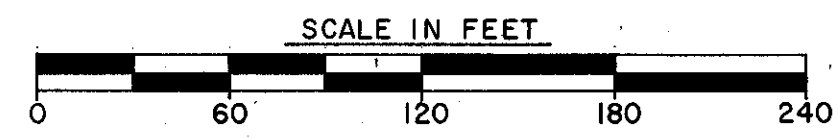


CALVARY ADDITION
