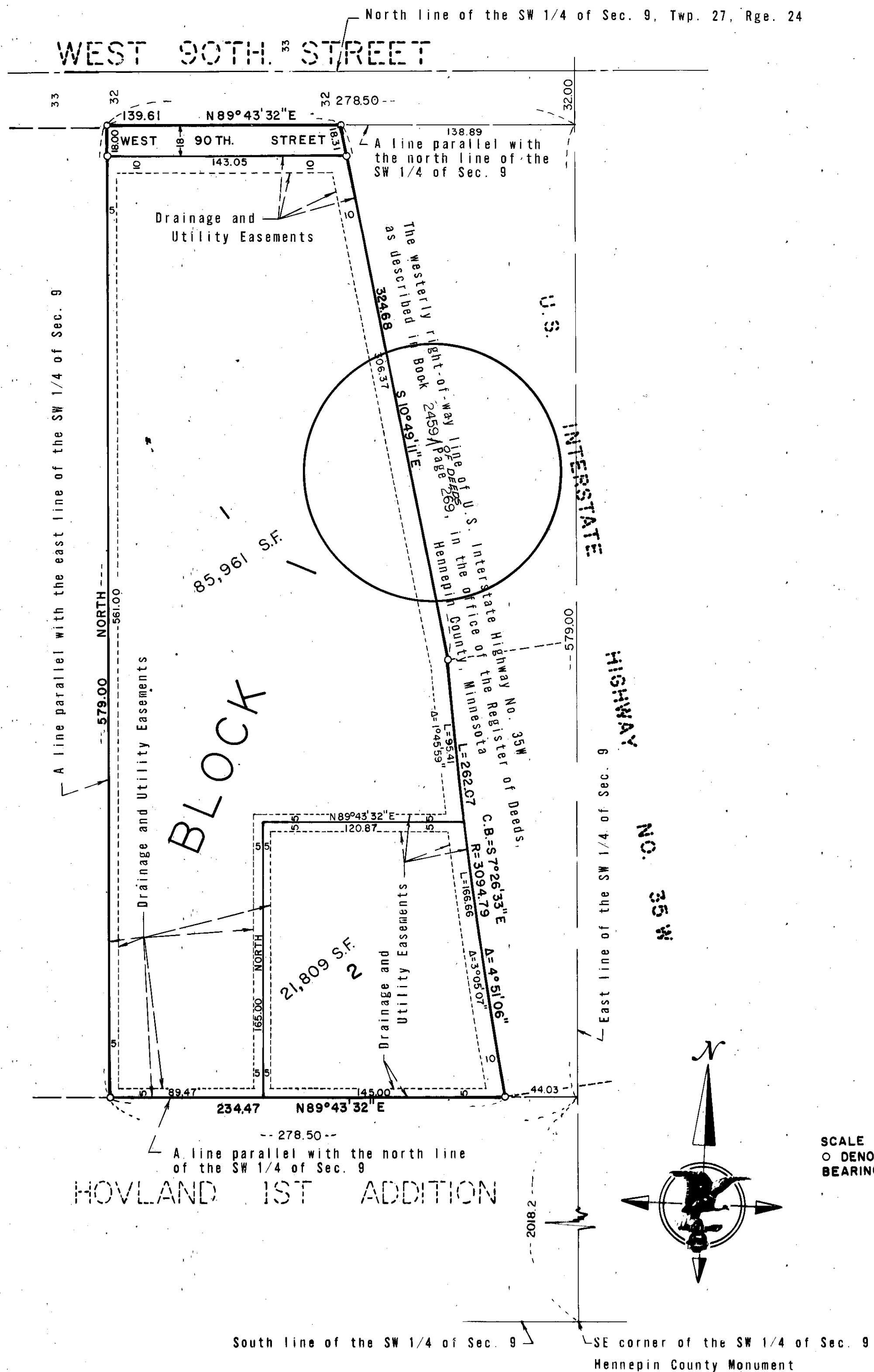


CHURCH OF CHRIST 1ST ADDITION
