

## FORD 1ST ADDITION FREEWAY






SCALE: 1 INCH = 100 FEET

KNOW ALL MEN BY THESE PRESENTS: That Walter J. Swanson and Lucille H. Swanson, husband and wife, owners and proprietors, of the following described property, situate in the County of Hennepin, State of Minnesota, to wit:

Beginning at a point twenty-six (26) rods South of Northeast corner of the Southeast Quarter (SE 1/4) of the Northeast Quarter (NE 1/4) of Section sixteen (16), Township twenty-seven (27), Range twenty-four (24), thence North along the East line thereof a distance of sixty-eight (68) feet; thence West and parallel with the South line three hundred thirty (330) feet; thence South and parallel with East line a distance of sixty-eight (68) feet more or less, to the intersection with a line drawn West from the point of beginning and parallel to the North Pine of the Southeast 1/4 (SE 1/4) of said Northeast 1/4 (NE 1/4); thence East along said last described line to the point of beginning.
