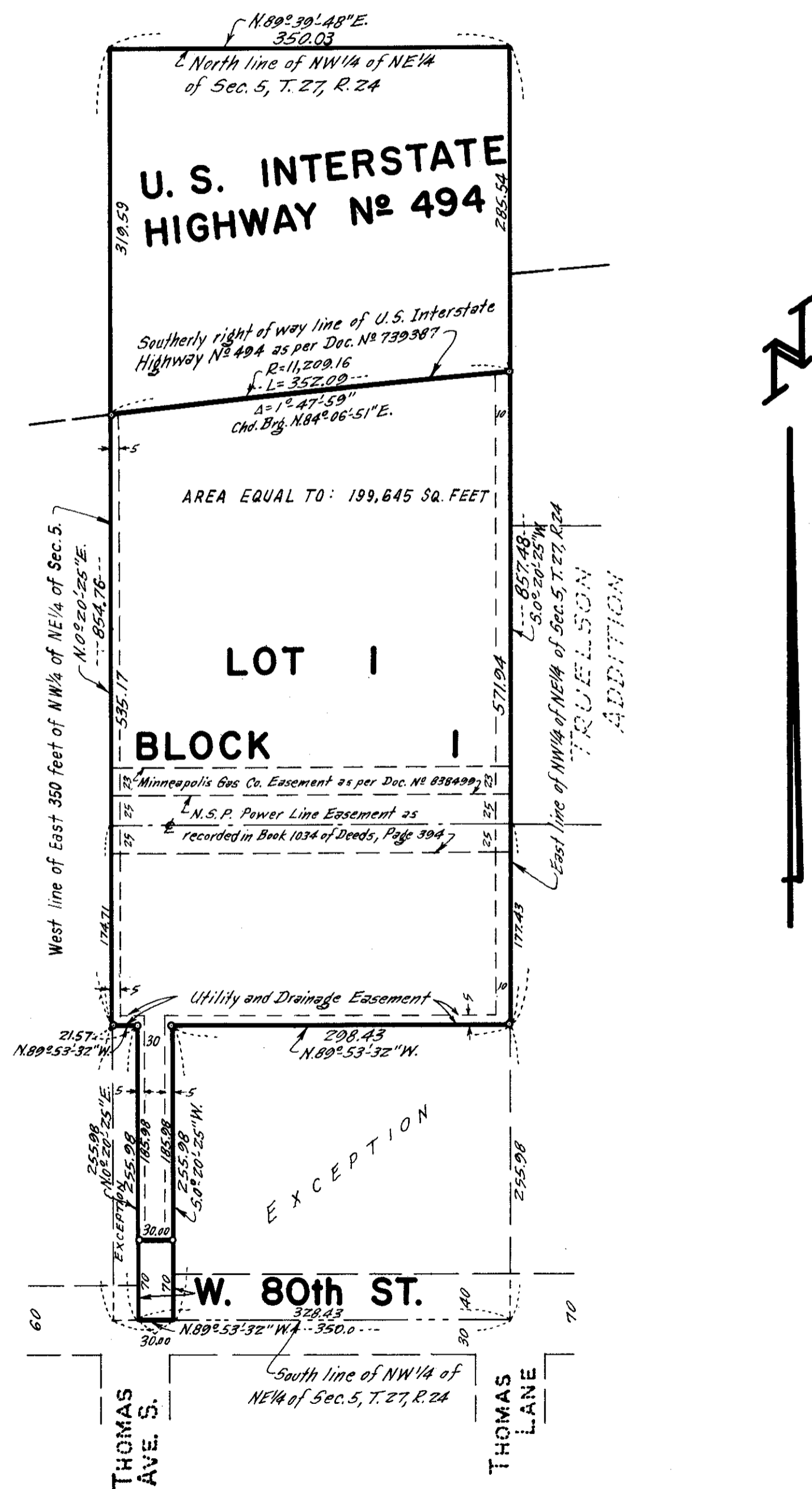


HOWARD WONG ADDITION
