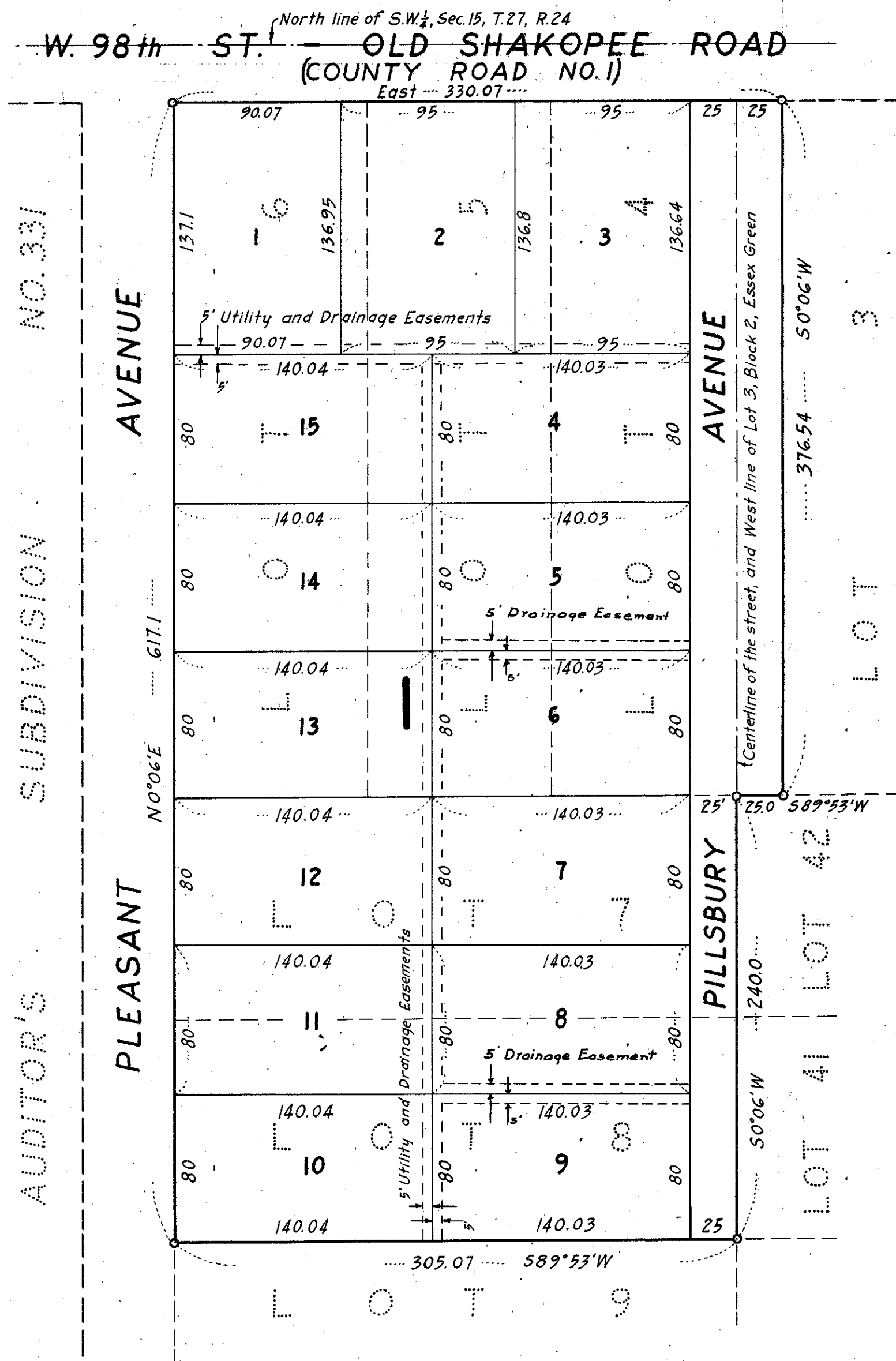
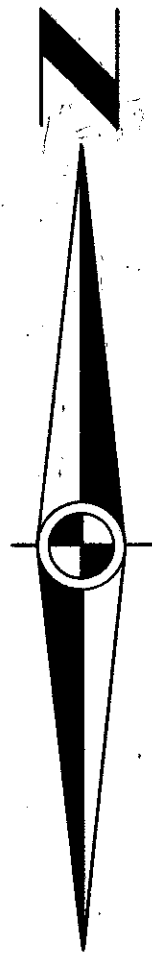


MILLIE BUTLER ADDITION
