
## SOLAR INC. 1ST ADDITION



KNOW ALL MEN BY THESE PRESENTS: That Solar, Inc., a Minnesota corporation, owner and proprietor, and Northwestern National Bank Southwest, a United States corporation, mortgagee of the following described land, situate in the County of Hennepin, State of Minnesota, to wit:

Parcel 1: That part of the South One-Half of the Southwest Quarter of Section 9, Township 27, Range 24, described as commencing at the Northeast corner of the Southwest Quarter of Section 9, thence West along the North line of said Southwest Quarter a distance of 1210 feet; thence South along a line which intersects the South line of said Southwest Quarter at a point 1211 feet West from the Southeast corner thereof, a distance of 1751.2 feet to the point of beginning; thence continuing South along said last described line 186.65 feet; thence West to a point on the West line of said Southwest Quarter a distance of 1938.85 feet South from the Northwest corner of said Southwest Quarter; thence North along said West line 186.85 feet; thence East to the point of beginning, except the East 345 feet thereof, according to the Government Survey thereof; and

Parcel 2: That part of the South One-Half of the Southwest Quarter of Section 9, Township 27, Range 24, described as commencing at the Northeast corner of the Southwest Quarter of Section 9; thence West along the North line of said Southwest Quarter a distance of 1210 feet, thence South along a line which intersects the South line of said Southwest Quarter at a point 1211 feet West from the Southeast corner thereof, a distance of 1592.5 feet to the point of beginning; thence continuing South along the last described line 158.7 feet; thence West to a point on the West line of said Southwest Quarter distant 1752 feet South from the Northwest corner of said Southwest Quarter; thence North along said West line 158.7 feet; thence East to the point of beginning, according to the Government Survey thereof.

Have caused the same to be surveyed and platted as SOLAR INC. 1ST ADDITION and do hereby donate and dedicate to the public for public use forever the avenue and drainage and utility easements.
