

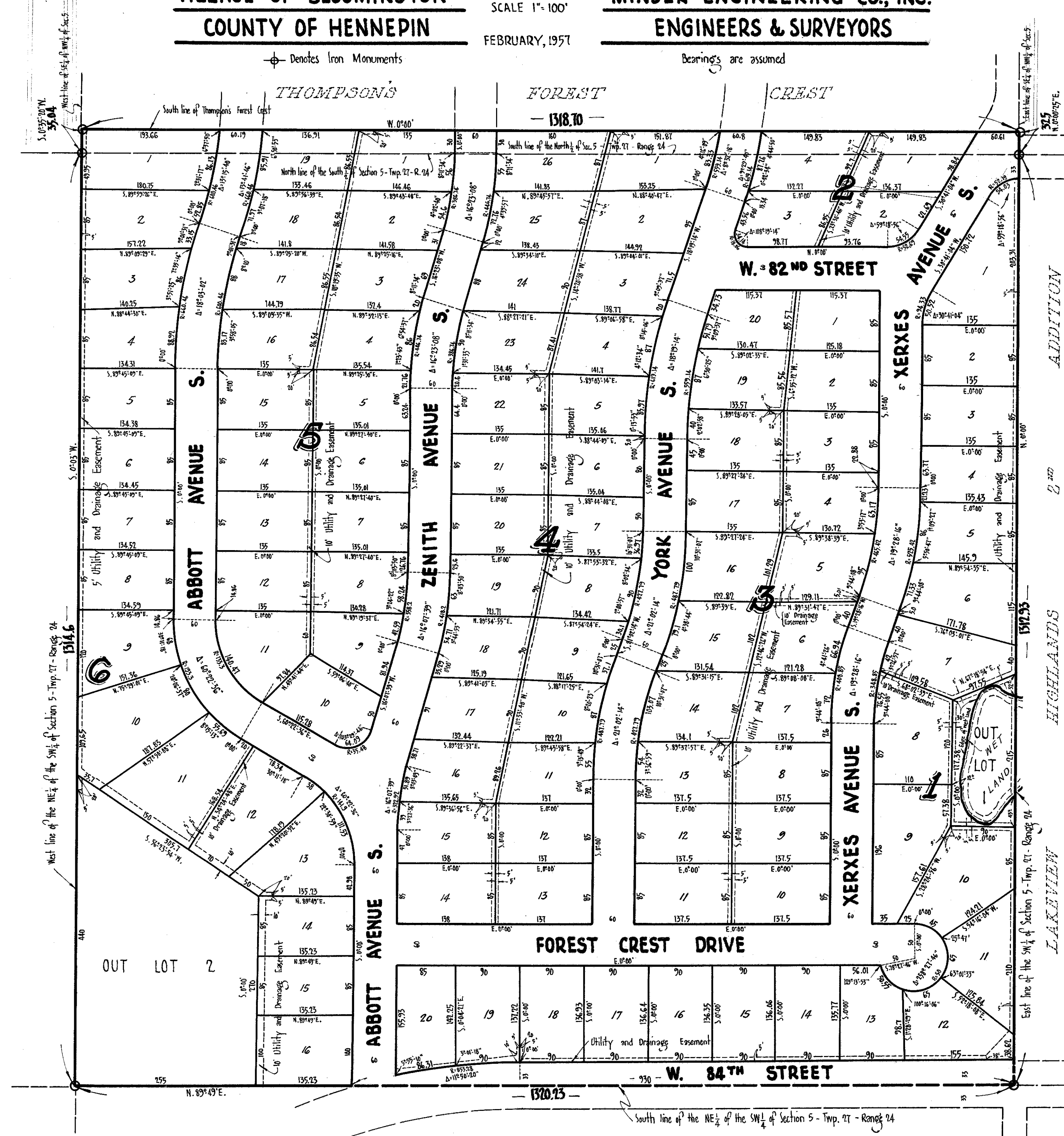
THOMPSON'S FOREST CREST 2ND ADDITION
