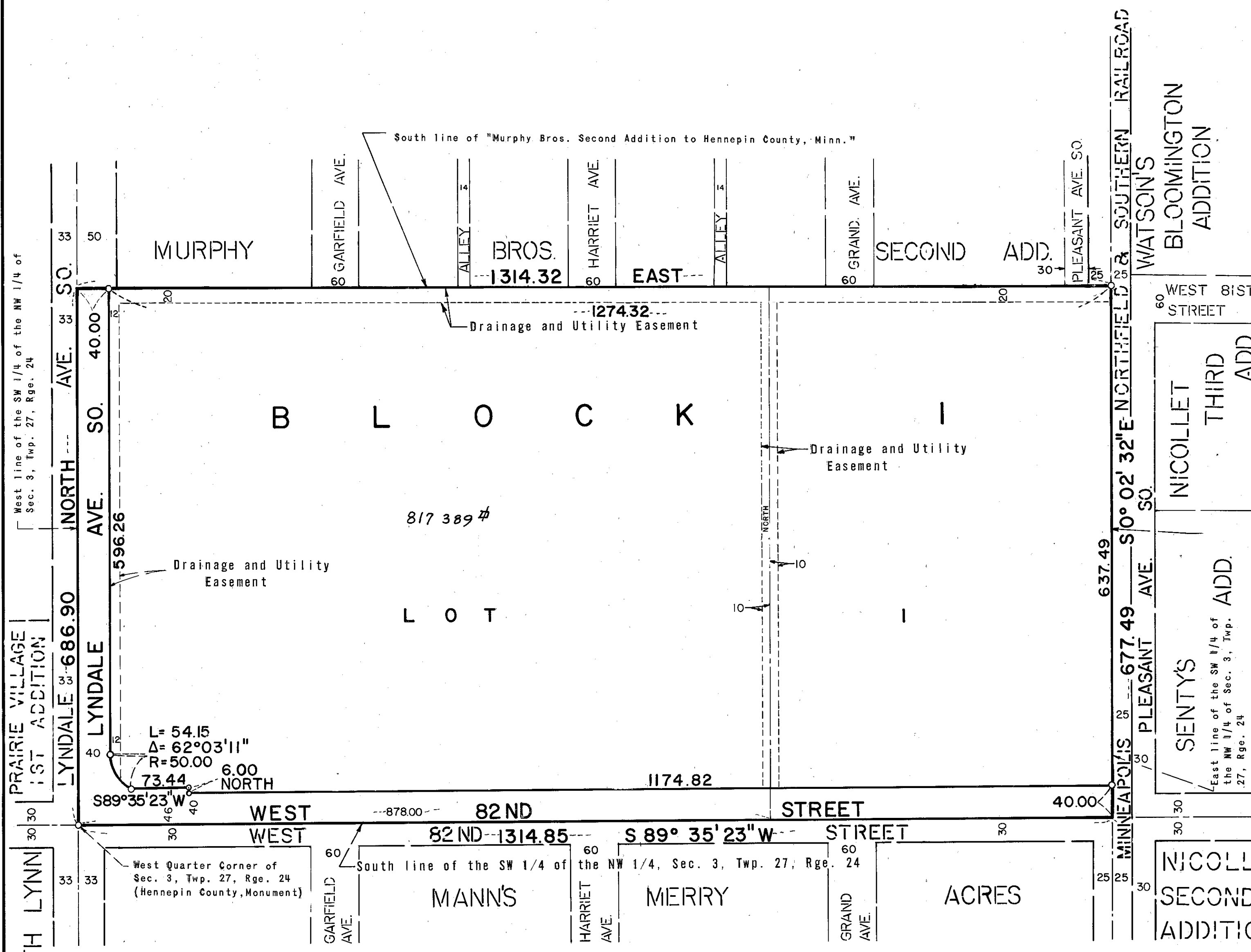


THIS SPACE RESERVED FOR BINDING

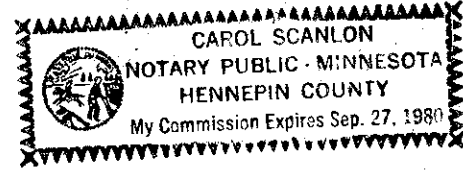
