What are Recreational vehicles & Off road vehicles?



- *Scooters are now legal on local streets (<u>new Aug 1, 2005</u>) SS 169.225
- Age 12 to 17 Must have Helmets
- Under 15mph
- Right side of roadway & <u>must</u> walk across road for a left turn
- Still, illegal on sidewalks & parks. (Rec. vehicle ord. 8.66)

Electric Scooters



- Are now legal on local streets (<u>new Aug 1</u>, <u>2005</u>) SS 169.225
- prohibited on sidewalks & Parks
- See City code 8.66

& S.S. 169.225

Power Boards or Dirt surfers



- Gas or electric powered
- 22 or 30 mph
- no light or safety features
- defined as Rec. vehicles and <u>prohibited on roads</u> and sidewalks & parks

Go Karts



- Gas powered
- No safety lighting or signals
- 5 hp motors
- Speeds to 25mph
- Def. As "Recreational vehicle" -city code
- illegal streets/ sidewalks & parks

Mini Bikes



- 50 to 80 cc engines
- Speeds up to 35mph
- Off road use only
- <u>Prohibited Rec.</u>
 <u>Vehicle.</u>
- No Street, sidewalk or parks

Mopeds (Legal)



- Can be street legal
- up to 30 mph
- Can <u>be licensed</u> and drivers issued moped permits
- Have safety features
- Are NOT Rec. vehicles have transportation aspect.
- Need to follow traffic laws.

Motorized bike





- Legal not "Rec. vehicles
- Have pedals and can be self propelled
- Two tandem wheels
- Motor less that 50cc
- Max speed 30mph
- Ok on Street as bikes <u>Not</u> on sidewalk or parks.
- Lic. Or a permit needed.
